Glasgow City Child Protection (CPC) and Adult Support and Protection Committees (ASPC) are hosting a joint one day Glasgow Public Protection Committees Conference on 15th May 2025.

The conference will be centred around **Transitional Safeguarding**, aiming to explore the critical issues faced by young people as they journey through adolescence into adulthood. This transitional period is often marked by vulnerability, and the conference focuses on ensuring that safeguarding practices effectively support young people during this critical time.

Other key themes associated with transitional safeguarding, which are pertinent to child and adult protection in Glasgow, will also be presented:

- Embedding a trauma-informed and responsive approach across services, systems and workforces
- Online safety
- Criminal exploitation
- Domestic abuse

## Adults, Older People & Dementia

### [Back to Cutbacks: How older people are managing the cost of living in a time of rising energy prices](#)

This report from Age UK highlights concerns about the impact on older people of rising energy costs and the struggles older people face affording the basics, especially after the loss of the Winter Fuel Payment for many on low and modest incomes, including those with health conditions.

### [Best Practice for Effective Access and Involvement of Independent Advocacy for an Adult in Adult support and Protection Processes](#)

This resource from the National ASP Implementation Group is aimed at any (multi agency) professional involved in Adult Support and Protection case conferences. The document offers good practice guidance to effective consideration and engagement of independent advocacy for adults being supported and protected under the Adult Support & Protection (Scotland) Act 2007, and in order to meet the responsibility laid out in the section 6 of the Act.

### [ASpire Webinar Recording: Financial Harm Affecting Adults - February 2025](#)

An ASpire webinar from February 2025 with the theme of financial harm affecting older adults. It had inputs on multi-agency shared learning from the outcome of the McCulloch Brothers Review (Highland), financial harm, adult Protection and decision-making (Dr Melanie Durowse), and explaining the role of the Office of the Public Guardian in relation to financial harm affecting older adults (Fiona Brown). The toolkit has been created by the Mental Health Improvement Team for anyone who works with a child or young person. It outlines eight key building blocks of digital wellbeing in a Digital Wellbeing Wheel (mapped against the SHANARRI indicators) and shares hints and tips for talking about children and young people's online lives. By having these conversations regularly and often, collectively we can support children and young people to have healthier and happier online experiences.

### [Alternatives to Depriving Children of Their Liberty](#)

A report from the Youth Justice Improvement Board which replaces the original Alternatives to Secure Care and/or Custody guidance published in 2011 as part of the initial suite of Whole System Approach (WSA) guidance. It seeks to reflect developments in policy, practice and legislation since that time, and to assist

practitioners to fully consider alternative approaches, thereby ensuring that deprivation of liberty occurs as rarely as possible, for as short a period as is necessary, and when that represents the best intervention in the particular circumstances.

### [National Parental Mental Health and Child Welfare and Protection Learning Resources](#)

A learning and development resource pack created following the publication of National Guidance for Child Protection in Scotland 2021 – updated 2023 in recognition of the number of children and young people who are on the child protection register as a result of parental mental health issues. New research from the University of Glasgow has found that four out of five males in prison have a history of significant head injury, with many having been exposed to repeated head injuries over time.

This occasional paper from the Scottish Government presents new exploratory analysis on an accused person's criminal justice journey time from offence date to verdict date in court by various equality related factors. The analysis explores how the length of an accused person's justice journey time varies depending on their sex, age, ethnic group and socio-economic status. This analysis only relates to accused proceeded against in court and does not cover accused who leave the justice system at earlier points.
