Dear colleague,

20th February 2025 is **National Adult Support and Protection Awareness Day**. This year's theme is financial harm. Financial harm can cover theft, fraud and pressure to sign over property or money. It also relates to rogue traders, online scammers and misuse of benefits.

People can be at increased risk to be harmed financially through factors such as ill health, trauma and physical or mental health conditions.

It can happen anywhere - in someone's home, where they work, or in a public place - and is often caused by the people closest to them. It can even happen in places responsible for keeping someone safe, such as a care home, hospital or day centre.

It's important to speak up about any concerns you have, as the person may not be able to do so themselves.

If you're worried that someone is at risk of harm or neglect from others - or harming or neglecting themselves - visit www.glasgowadultprotection.org.uk for all the relevant contact details.

Alternatively, you can contact the Police on 101 or call 999 if you believe the person is in immediate danger.

<u>Findings a Safe Home After Hospital: Case study research on supported housing</u> and healthcare partnerships

Research from the National Housing Federation which explores existing evidence on the impact of housing-related delayed hospital discharges and the important role that supported housing can play in preventing delays and alleviating pressure on the NHS. Drawing on a series of case studies, this report showcases how the NHS and supported housing providers are working together to remove barriers to finding a safe home and support people leaving hospital at the right time for their recovery.

Children, Young People & Families

Artificial Intelligence and Online Child Sexual Exploitation

WeProtect Global Alliance today unveiled a compelling short film, <u>Protect Us</u>, exposing the harrowing ways generative Al applications and chatbots are being weaponised to exploit children online. Premiering today at the DLD Conference in Munich, the film calls on global leaders to take decisive action to safeguard children and young people.

<u>Safeguarding Voice:</u> Effectively engaging fathers in safeguarding practice podcast Future Men has released a podcast episode looking at how to engage fathers in safeguarding practice and involve them in support for children and young people. The episode explores current research, engagement strategies and the impact this can have on children, families and communities.

Behind the Screen - Sexually Coerced Extortion of Boys and Young Men

Childline has launched a new campaign, Behind the Screen, raising awareness of the sexually coerced extortion of boys and young men. Sexually coerced extortion or 'sextortion' is a form of online blackmail involving a threat to share intimate or explicit images or videos to extort money or get someone to do something against their will. The campaign resources include a new film aimed at young people which involves an AI generated image challenge and a guide for professionals which looks at what sexually coerced extortion is and how to support young people.

Help Emerging for Children of Parents who Hoard

An article from the Guardian which highlights that local authorities are being urged to intervene earlier when there are children whose parents hoard. HoardingUK charity is also preparing to launch dedicated online support group in April.

Advice for Parents or Carers of Children Who Are Being Sexually Extorted or 'Sextorted'

This guide from the Internet Watch Foundation aims to empower parents by providing essential steps and insights on how to handle the traumatic situation of child sextortion. By understanding the nature of the crime and taking prompt action, you can support your child and work towards mitigating the potential harm caused.

<u>Children's Manifesto Expresses Hope for Better Education on Al Ahead of Paris Al</u> Action Summit

An article from The Alan Turning Institute highlighting the messages from a children's manifesto which was published at the Al Action Summit in Paris where

children and young people want to see better education on AI to improve understanding and maximise its use.

State of the Nations' Foster Care: Full report

This webinar from CELCIS offered attendees the opportunity to gain insights into the themes and findings of the Children's Services Reform Research study to understand the significance of these for efforts to reform services, and to explore where we are now and what it takes to make change happen to provide the essential learning needed for progressing improvements to make transformational and meaningful change in children's services. A practice guide for young children and their families, commissioned by the UK government, has been published by Foundations. It looks at parenting through adversity for children under 10.

The Oversight Board for The Promise: Report three February 2025

On the 5th anniversary of The Promise, The Oversight Board published its third progress report which focuses on whole family support and the workforce, and it reveals that The Promise is not currently on track.

<u>Care Experienced Children and Young People: Research insights from</u> administrative data

This report from the National Centre for Social Research summarises some key insights on children's experiences with social care, which have been generated through research using administrative data. It serves as a source of evidence for policymakers and practitioners working to support children. It also provides a rich example of the power of administrative data to enable critical research evidence that can improve lives. There is also an infographic.

<u>Scotland's Children's Services Plans 2023-2026 Review: Improving outcomes for children, young people and families</u>

A review of children's services plans for 2023 to 2026, in line with Part 3 of the Children and Young People (Scotland) Act 2014. This report from the Scotlish Government presents key findings from the review of Scotland's 30 Children's Services Plans (CSPs) which cover the planning cycle for 2023 to 2026.

A Review of Antisocial Behaviour in Scotland

A report from the Children and Young Person's Centre for Justice (CYCJ) which presents a review of the antisocial behaviour literature and a Qualtrics survey was developed in partnership between the ASB Independent Working Group and the Children and Young People's Centre for Justice (CYCJ).

Disability, Learning Difficulties & Neurodiversity

Research Finds That Young Adults with Learning Disabilities Are Dying Prematurely Young adults with learning disabilities are nine times more likely to die from treatable causes compared to those in the general population, according to Glasgow researchers. The new study, led by the Scottish Learning Disabilities Observatory, also found that overall, for adults of all ages with learning disabilities, the risk of premature mortality is three times higher.

Home Education Guidance

The Scottish Government has published updated Home Education Guidance, which outlines the responsibilities of local authorities and considerations which need to take place when a request is made to withdraw a child from school.

Financially Motivated Sexual Extortion: Alert for education settings

An alert from the National Crime Agency about the increase in reports of children and young people being forced into financially motivated sexual extortion.

Schools in Scotland Witness an Increase in Violence

An article from The Guardian which highlights that Scottish schools are facing "an exponential increase" in pupil violence, with classroom behaviour deteriorating "massively" and absences outstripping England, according to teaching unions, behaviour experts and opposition politicians.

In this webinar from CYCJ, Dr Peter Yates will provide an overview of some of the main findings and key recommendations for practice from a comprehensive review of forty years of research on sibling sexual abuse. This review was published in the Child Abuse and Neglect Journal in 2024.

How to Support a Person with Fetal Alcohol Spectrum Disorder webinar - 26/02/24 - 1pm-2pm

Webinar from Learning Disability Today aimed at parents, carers and professionals working in health and social care. The webinar includes presentations from Brian Roberts, Director of Education & Wellbeing, National Organisation for FASD and Georgia Roberts, Self-advocate who will discuss innovative approaches to help support those living with the condition.

ASP Spotlight Session: Financial harm webinar - 26/02/25 - 11am-12noon - MS Teams

This webinar will explore the different types of financial harm that practitioners can encounter in day to day ASP practice. This includes 'newer' types of harm such as romance fraud and online scams. Adult Support and Protection Multi Agency Training Awareness Webinar

A multi-agency webinar delivered by Learning and Development, Glasgow HSCP (Health and Social Care Partnership) to support practitioners to gain a basic understanding of Adult Support and Protection (ASP) legislation. It may be used as a basic awareness or if you already have some knowledge of ASP and wish to refresh your skills. This is a multi- agency awareness session and will webinar-based with a maximum of 60 participants. There will not be a waiting list so if you are unsuccessful you will require to reserve an alternative date. Participants will:

- develop their understanding of what we mean by an adult at risk within the context of the Adult Support and Protection (Scotland) Act 2007
- define who may be an adult at risk of harm
- recognise forms of harm adults may experience
- know how to report their concerns

explain their responsibility in relation to Adult Support and Protection.

Health and Social Care

National Care Service Update

The Scottish Government's Minister for Social Care, Mental Wellbeing and Sport, Maree Todd, has announced that the Scottish Government will not proceed with Part

One of the National Care Service (NCS) Bill, effectively scrapping the planned structural reform of social care in Scotland, and instead will create a new non-statutory advisory board of people with lived experience of accessing care, social care workers, care providers, trade unions, the NHS and local authorities – it has published a factsheet outlining its intentions in progressing elements of the NCS plans.

Digital Toolkit to Help People Living with Dissociative Seizures Launched

NHS Greater Glasgow and Clyde has developed a digital tool to help patients and their families manage a condition that was once so difficult to spot it was dismissed as a figment of a patient's imagination.

Public Expenditure in the Last Year of Life

Marie Curie commissioned this research to estimate the range of public expenditure that supports the care of people in their last year of life. This includes health care in community and acute settings; hospice care; social care for people in their homes and in institutions; and social security benefits. There is also a <u>briefing paper</u>.

Innovating for Independence: A win-win for health and social care

This policy briefing from Reform calls for quick action to scale up technology within social care. It points out that too much of the technology in social care is not being scaled and is stuck in small scale pilots that are not having the system-wide impact they could achieve.

Economic and Social Value of the UK Adult Social Care Sector: Scotland

This report from Skills for Care & Development presents an analysis of the adult social care sector's economic and social value in Scotland using data from 2022/23. The report is used to inform the economic case for investment in the social care sector and its workforce in Scotland. It is also used to inform policy-making and national spending review decisions on investment. There is also a summary report and infographic.

Number of Children Living in Temporary Accommodation Surpasses 10,000 More than 10,000 children are living in temporary accommodation across Scotland after an increase of 6% over a period of 12 months, new figures have revealed.

Temporary Restriction on Rent Increases to be Withdrawn at the End of March 2025 Temporary restrictions on rent increases in the private rented sector will be withdrawn at the end of March 2025, the Scottish Government has confirmed.

An intersectional lens is applied in this year's report, with chapters focusing on gender and nationality exploring how youth homelessness is experienced by different groups of young people. Former patients at Scotland's biggest children's psychiatric hospital have spoken out about a culture of cruelty among nursing staff.

A learning review into the circumstances leading up to the removal of a newborn baby from his mother. A Child Protection Order was granted due to increasing concerns about Ms A's mental health and her ability to safely care for her child.

Migrant Workers in UK to Fill Care Roles Charged Illegal Fees

An article from the Guardian which highlights that migrant workers who come to the UK to bolster the country's care system are having to share beds, sleep rough, and are in some cases being charged more than £20,000 in illegal fees, according to research.
