Adults, Older People and Dementia

What Needs to Improve for Social Care to Better Support People with Dementia?

This report from the Nuffield Trust sets out what the current challenges are with providing good social care for people with dementia and makes recommendations about what needs to change to improve social care for people with dementia. There is also a <u>summary document</u>.

Scotland's Redress Scheme: progress updates - November 2024

Update from the Scottish Government on developments with Scotland's Redress Scheme.

Supported Decision Making: Good practice guide

This guidance from the Mental Welfare Commission sets out why supported decision-making is an important concept. It explains how adults with mental illness (including dementia), learning disabilities and other related conditions, who may have difficulty making decisions, can be supported to ensure that decisions made, by or about them, genuinely reflect their choices.

Ageing and Frailty Standards

Health Improvement Scotland has published standards for ageing and frailty in Scotland drawing on improvement work, lived experience, best practice and stakeholder recommendations.

Carers Urged to Check for Financial Help

Unpaid carers are being urged to check their eligibility for financial support as thousands could be missing out.

<u>Unpaid Carers Save Scottish Economy NHS-scale</u> Costs

Unpaid labour carried out by Scotland's carers is estimated to have saved the Scottish economy £15.9bn in 2022/23 – four times more than the total government spend on adult social care services.

Towards Modernising Adoption in Scotland: A focused mapping review

A CELCIS focused mapping review of selected literature from the last five years on recent changes and approaches that have developed in adoption services and practice.

One Punch: The Impact of Serious Youth Violence

A video from the Youth Justice Board which explores restorative justice and serious violence and has been scripted, animated and co-produced with children. It uses animation to anonymise them, while still ensuring their voices and experiences are

heard. The video allowed them to explore their feelings and reflect on their experiences of the youth justice service and what helped them.

Children and Families Across Borders – Cultural Guide

Children and Families Across Borders have published their newest cultural guide for professionals working with children and families of Nigerian heritage. The Cultural Family Life Library provides a range of resources covering families from a variety of cultures and religions.

<u>Progressing the Human Rights of Children in Scotland: Update report 2021-2024</u>
This report from the Scottish Government provides an update on the delivery of commitments outlined in our action plan 'Progressing the human rights of children in Scotland: action plan 2021 to 2024'.

<u>Criminal Exploitation Of Children Rises By 55 Per Cent In Two Years</u>

The Centre for Young Lives has found that children were identified by social services as victims of criminal or sexual exploitation or being involved in gangs almost 40,000 times over the last year.

New Tech Enables Thousands of Additional Child Victims to be Counted in Sexual Abuse Images for the First Time

More child sexual abuse victims can now be 'seen' and counted than ever before, thanks to new tech that allows the Internet Watch Foundation (IWF), the UK's front line against child sexual abuse imagery online, to record all the children seen in sexual abuse images.

The Impact of Financial Pressures on Young People

NSPCC Helplines Insight Briefing shares young people's experiences of financial pressures. Key themes include material hardship and housing instability, impacts on family dynamics, barriers to accessing support, plus hopes and worries for the future.

Supporting Adoption: A vision and priorities for Scotland

This statement sets out the Scottish Government's vision for adoption in Scotland, the importance of support for the adoption community, and strategic priorities to achieve this. There is also a summary version.

To better understand the experiences of children and young people who have spent time living with kinship carers, CELCIS and the Scottish Centre for Administrative Data Research (SCADR) brought together, for the first time, a body of data about these children's lives – including information on their care experiences, education and early childhood development. DigiFest 2024

DigiFest is Scotland's annual Digital Health and Care knowledge exchange event, organised by the Scottish Government's Digital Health and Care Division and their Steering Group partners and continues to be an anchor event for the Scottish digital health and care ecosystem. DigiFest24 combines a programme of free-to-attend, virtual and in-person satellite sessions, from October 2024 onwards and a virtual conference, featuring panel discussions and sharing good practice on 4-5 December 2024.

Risk Outside The Home (ROTH) Pathway Learning Event - 10/12/24 - 10am-2pm - MS Teams

At this event Professor Carlene Firmin and other members of the Contextual Safeguarding research team will share learning from Phase 3 of the ROTH project, in partnership with representatives from the four pilot sites. We will also consult attendees on the planned programme of work for Phase 4 of the project which will

commence in 2025 to scale key points of learning into other areas interested in ROTH pathways, as well as sustain the progress made by the original pilot sites.

<u>Using Child Sexual Abuse Resources in Children and Family Social Work Webinar - 16/12/24 - 1pm-2pm</u>

This webinar will look at free resources developed by Lucy Faithfull Foundation and Stop It Now that can be used in supporting families where there are significant risk factors and low protective factors. Child Protection Lead Online Training - 05/03/25 - 10am-3pm

Children In Scotland are offering training on the role of child protection leads within organisations. This interactive training course will provide learners with the skills and knowledge required to carry out the role and responsibilities of the Child Protection Lead. The themes of the day include a focus on legislation and guidance, referral procedures and supporting and responding to staff & volunteers thereby developing confidence in the role and promoting best practice in safeguarding children and young people. Please note that there is a cost to attend this training.

Adult Support and Protection Multi Agency Training Awareness Webinar

A multi-agency webinar delivered by Learning and Development, Glasgow HSCP (Health and Social Care Partnership) to support practitioners to gain a basic understanding of Adult Support and Protection (ASP) legislation. It may be used as a basic awareness or if you already have some knowledge of ASP and wish to refresh your skills. This is a multi- agency awareness session and will webinar-based with a maximum of 60 participants. There will not be a waiting list so if you are unsuccessful you will require to reserve an alternative date. Participants will:

- develop their understanding of what we mean by an adult at risk within the context of the Adult Support and Protection (Scotland) Act 2007;
- define who may be an adult at risk of harm;
- recognise forms of harm adults may experience;
- know how to report their concerns.
- explain their responsibility in relation to Adult Support and Protection.

Due to the high demand for the training, we recommend that you book 1 place but having up to 8 additional staff members join in your room and attend this training session.

Child Protection Awareness Multi-Agency Online Training

This multi-agency training will support practitioners to gain a basic understanding of Child Protection, even where your job is such that you have no direct responsibility for providing a service to them. It may be used as a basic awareness or if you already have some knowledge of Child Protection and wish to refresh your skills. Participants will:

- Understand types of harm and the potential impact on a child;
- Understand your role and responsibility in recognising and responding to the risk of harm;

- Understand the process and importance of information sharing;
- Understand the processes professionals take to assess and support any child at risk of harm.

Mental Health & Trauma

National Specification for the Care and Treatment of Eating Disorders in Scotland National specifications for the care and treatment of eating disorders in Scotland, developed in response to the National Review of Eating Disorder Services.

Mental Health Inpatient Settings: Out of area placements

Anti-Racism in Social Work: A statement of intent by the Social Work Anti-racism Oversight Group

A statement of intent from the Scottish Government outlining the vision for antiracism in social work, including top priorities to address systemic racism in the sector.

Renfrewshire Child Protection Committee: Learning Review - Child 3

A learning review carried out following the death of a four-year-old boy and his father. Due to the father's history of mental ill health, Child 3 and his father were both in receipt of a multi-agency package of support from child protection and adult support services.

The Care Inspectorate, as a member of Restraint Reduction Scotland, has therefore worked collaboratively with the Scottish Physical Restraint Action Group (SPRAG) to review and update our restrictive practices self-evaluation tool.

<u>Joint Inspection of Adult Services: Integration and outcomes - focus on people living with mental illness - Clackmannanshire and Stirling Health and Social Care</u> Partnership

The Care Inspectorate and Healthcare Improvement Scotland's joint inspections seek to address the following question: "How effectively is the partnership working together, strategically and operationally, to deliver seamless services that achieve good health and wellbeing outcomes for adults?" The inspection in the

Clackmannanshire and Stirling Health and Social Care Partnership was the fifth in the series of inspections, and the second to consider the inspection question through the lens of people living with mental illness.

Scotland's Local Government Workforce Report 2024

Scotland's Local Government Workforce Report 2024 has been published by the Society of Personnel and Development Scotland, Solace Scotland and the Improvement Service.

Building Bridges Resources

Building Bridges is a set of resources developed to support staff in any type of service to feel more confident in responding to women's disclosures of selling sex. Created with input from women with lived experience and support services, our resource pack includes an animation, guidance and training presentation.

Refugees, Asylum, Trafficking and Immigration
