## Emergency PPE Supplies for People who use Direct Payments to Purchase Social Care Support

We are writing to you because you receive a Direct Payment (DP) from Glasgow City Health and Social Care Partnership (GCHSCP). We wanted to make you aware of a new development about Public Protection Equipment (PPE) which was announced by the Scottish Government this week. From the 27th April 2020, small, emergency supplies of PPE can be requested by people who receive DPs. It is important to say that the responsibility for providing PPE for Personal Assistants (PAs) remains with the DP holder as the employer. What is being made available to DP holders through the new system, is a short term supply of PPE which can be called on in emergencies.

This has been introduced because of the difficulties some people are experiencing when they are trying to buy PPE from their usual suppliers.

Under the new Government arrangements, you may be able to access emergency PPE supplies if:

 You employ your own Personal Assistants AND you cannot buy PPE through your usual suppliers or there is a delay in your PPE supplies arriving or some of the PPE items you need are not available

To help us make best use of the resources available, please let us know if:

- You have tested positive for Co-vid 19 or
- You have symptoms of Co-vid 19 or
- You have received a "Shielding Letter" from the NHS or
- You have underlying health conditions which make you more vulnerable to Co-vid 19.
