#### 1. Purpose

1.1 The purpose of this report is to present a timetable for reporting upon performance to future meetings of the Integration Joint Board Finance and Audit Committee.

#### 2. Background

- 2.1 The first full joint Performance Report, which brought together the performance indicators previously produced separately for Health and Social Work within a single draft Joint Performance Report, was presented to the last meeting of the Integration Joint Board Finance and Audit Committee on 12 September 2016. This report captured the performance of the Health and Social Care Partnership, in relation to a range of key performance indicators across Health and Social Work Services.
- 2.2 At this meeting, the format and content of the report was approved and it was agreed that it should be produced on a quarterly basis going forward. It was also agreed that it would be beneficial to focus upon particular care groups at each Integration Joint Board Finance and Audit Committee meeting, to allow more detailed scrutiny of performance and consideration of key issues and challenges which may be being experienced.

#### 3. **Reporting Timetable**

- 3.1 A reporting timetable for the production of future reports has been produced and is attached in Appendix 1. This sets out:
  - When the reports will be produced
