Chair of Parkhead Community Council membership of Community Planning, Public Partnership Forum, Locality Engagement Forums, and many other local community groups and organisations.

John was fully involved in the public consultation around the Parkhead Health and Social Care Hub from the initial planning and development stage and continued involved as a community representative serving on a number of Hub working groups. John received several honours for his tireless work, for his local community including an MBE in 2000.







Presentation by Kate Tobin Planning and Performance Manager,
Planning Team, Glasgow City Health and Social Care Partnership
(HSCP)

Kate explained that the HSCP is developing a new Locality Plan setting out how they will deliver health/social care services in Northeast Glasgow. The meeting opened up to allow LEF members space to reflect on strengths, challenges and opportunities in their local area around health, social care and wellbeing. It asked LEF members: What Matters to You? in the development of a Locality Plan.

The group outlined a rich range of supports they felt were particular assets in Glasgow and the North East. Challenges and Opportunities:

- Creating appropriate public sector infrastructure where there are new housing developments
- Creating more affordable and engaging spaces and activities for children and young people (particularly during the summer)
- Building better awareness of supports and services available – particularly for those who are new to area
- Make volunteering more accessible
- Progress with suicide prevention strategies – particularly for those who are most vulnerable
- Increase partnership working between public sector and voluntary sector
- Continue to raise awareness of the services and activities on offer within the Parkhead Hub
- Better lighting in the parks (particularly ahead of moving into the Winter period)
- Sustainable and longer-term funding for the voluntary sector

Kate thanked LEF members for their contribution and said that the HSCP is committed to continue engaging with a wide range of service users, community groups and partner and external organisations in the planning and development of services.
