OFFICIAL Welcome 1. Michael welcomed everyone to the meeting. Apologies were given and recorded. 2. **Previous Meeting Notes and Matters Arising** Notes from the development session were approved. Michael thanked and welcomed Emily Traynor and Brian McCarthy for attending and 3. speaking on the North West Alcohol & Drug Partnership. NW LEF 2 ET.pdf North West Locality Presentation BMcC.p Emily's presentation outlined the range of statutory services provided by the NW ADP, and shared information on The Thistle, Glasgow's Safer Drug Consumption Facility. Michael and Elspeth visited the facility and shared that the public can arrange visits out with operational hours. Brian's presentation highlighted a programme of activities delivered by the NW Recovery Communities. The programme aligns with the principles of Recovery Orientated Systems of Care and continually evolves using a person centred approach. The team are committed to gathering feedback to improve the service. It is reliant too on the support of their volunteers to deliver the activities. He identified how drug trends and intelligence are being used within the service. He welcomed future involvement with the LEF around engagement and consultations, and shared mobility, isolation, homelessness, bus passes, mental health are the barriers and issues facing the people attending NWRC. Action - Katrina to send registration form and database link to Brian **Chair and Members Updates** 4. Michael commented on the HSCP social posting on the NW LEF. He suggested the post is mis-leading and requested edits to future postings. Katrina reinforced the ways in which people can be involved in the HSCP. They can either join digitally via the NW database link and in-person or online at the meetings. The NW LEF meetings are for those who live, work and represent people in North West Glasgow. Members can share and signpost people to the HSCP link outlining the role and function of the LEF and if required contact can be made with the engagement leads. A member of Knightswood Connects expressed concern on its future and the impact this will have on older people in that area. Katrina shared that she met with the Community Engagement & Activities Officer. Due to the way the art class, music group, walking group, men's group, and exercise group are operating they are sustainable and could continue in that area. LEF members acknowledged this is a testament to the way the

activities have been developed and supported by members over the last 7 years.

If additional support was needed the HSCP could signpost people to other community organisations including Glasgow Life. Michael would communicate LEF members concerns with the NW Older People Team.

Glasgow Carers continues to grow and flourish. They actively post updates on their Facebook page and members are continuing to support the network meetings. Last month they received information from the 3 Carer Centres. In addition, members are attending carer network meetings to raise awareness of the group and gather carer's experience. The group has been asked to comment on the HSCP draft Carers Strategy 2025-2028, prior to its publication. It is envisaged it will be launched at an event during Carers Week (9th-15th June 2025).

LEF members highlighted concerns surrounding the engagement and consultation process on the Social Work Services Social Care Charging Policy for Non-Residential Chargeable Services. Whilst the overall aim of the survey was to gather a range of service user and carer views, the 14-day period to complete the survey was perceived by LEF members restrictive and limiting. LEF members acknowledged that many people who are required to pay a client contribution would require the survey in easy read format and/or informal or formal support to complete the survey. Those providing support to people indicated their input was minimal as it did not allow informal and formal advocates to submit multiple entries. Households with multiple service users and carers was also impacted if using a single device i.e. PC or mobile. Telephone assistance was available however it was inaccessible for some people and it was posted as a closed consultation on the HSCP website.

Action -

- Katrina and Michael to draft an email/letter stating LEF members concerns, and Katrina to identify the staff member/department to send correspondence

5. North-West Development Session

Michael shared that member's feedback to the survey was low. He encouraged members to complete the survey as this response would not result in any changes to the meeting schedule.
