1.	Welcome (RS)
	The Vice Chair, Sadie Gordon welcomed everyone to the meeting. Apologies were given and recorded. Katrina informed the group that no Chief Nurses would be in attendance to discuss the Nursing and Midwifery strategy.
2.	Previous Meeting Notes and Matters Arising (RS)
	Previous minutes were approved.
3.	<p>The Vice Chair thanked and welcomed Donnie McKinney for attending and speaking on Glasgow City HSCP Day Care Consultation.</p> <p>Donnie circulated paper copies of the consultation and signposted people to the consultation's web link, highlighting that the closing date is 1st September 2024. He presented on the background and context of the review. He informed members of the Internal Review carried out and the findings.</p> <div data-bbox="324 877 409 968"></div> <p>20240807 Day Care Presentation IV.pptx</p> <p>To remain impartial an external body would be involved in auditing the review process.</p> <p>He welcomed involvement from LEF members during the implementation phase and shared his contact details.</p> <p>He invited LEF members to the Older People Consultation Drop-in on the Tuesday 3rd September.</p>
3.	North-West Locality Plan
	<p>Gareth circulated draft copies of the North-West Locality Plan. He said it is proposed that it remains as a draft document for a period following submission to the IJB, to allow for further engagement. Following this the HSCP Communication Department will ensure to format into an inclusive and accessible format.</p> <p>He focused on LEF members sharing how they feel the plan should be introduced across the communities. He suggested that the lived and living experiences from people and organisations can demonstrate any issues and gaps across the HSCP.</p> <p>Discussed the options of three public meetings across the three HSCP Localities and one online meeting for people unable to access the public meetings. It was felt that we should connect with the existing local engagement structures in the North-West and extend the invite to the North- West Community Councils as the community needs differ</p>

	<p>considerably across the neighbourhoods. Ellen suggested that the HSCP consider if consultations on similar topics could be better aligned or sequenced to avoid duplication.
