1.	Welcome (RS)	
	The Vice Chair, Sadie Gordon welcomed everyone to the meeting. Apologies were given and recorded.	
2.	Previous Meeting Notes and Matters Arising (RS)	
	Previous minutes were approved.	
3.	North-West Locality Plan	
	Gareth shared that the North-West Locality Plan is still a working document and hopefully it will be available for the next meeting.	
	Linked to the pandemic there was a delay in producing the plan, and this prevented alignment and involvement with the strategic plan engagement processes.	
	This new draft plan is focussing on the progress of the HSCP Strategic Plan and advising how people can access further information on topics or service strategies. However, Gareth stressed the document itself is secondary to the importance of further engagement that is proposed to better understand people's experiences and views of progress at a more operational/frontline level.	
4.	LEF "looking back to look forward"	
	The LEF has met on six occasions since they returned to face-to-face meetings in November 2023. Katrina felt it was important for LEF members to reflect on the current format, frequency and locations of the meetings and encouraged their input and involvement with the planning of future meetings.	
	Members spoke of the format of previous meetings and requested more connection with the HSCP care groups. Katrina shared that the Older People Team wish to link directly with communities to find out What Matters to You. This was trialled in the Knightswood and Scotstoun area and we are keen to mirror this approach across the locality. Katrina has been linking with Sadie to plan a session within the Possilpark area.

	Katrina asked them to consider how the LEF should be connected/involved with care groups and either she or Gareth will link with the leads on their behalf. Gareth shared that the HSCP is due to re-establish the Learning Disability Care Group.	
	All members indicated they are happy with the duration of the meetings and rotating them across the neighbourhoods. It was agreed that due to holidays there would be no future July meetings scheduled. All discussed alternative venues across the North-West.	
	Members discussed a LEF Action Plan to focus the forum, this could include themed events such as linking young people and carers with the LEF.

5.	Promotional Material
	Katrina shared that we had LEF members resigning in 2023 and others wished only to be honorary members. She continues to promote the LEF across the community and though they have successfully recruited members during 2023/2024 she recognises that for some people the format and timings of LEF Meetings are not liked or accessible.
	Across the locality there are several opportunities for the LEF to connect with individuals and community groups via events. Katrina is keen the LEF uses this opportunity to grow people's involvement with the HSCP.
	Katrina suggested introducing a North-West Locality Database to encourage local people to be more involved in the decision-making processes and inform key policies. Katrina stressed that the database would need to be representative of the North-West's diverse population and we would need all LEF members to seek people from a wide range of backgrounds.
