10	Would or could the IJB committee consider taking these meetings to venues around the city to perhaps encourage public involvement?	Robert Smith	Involvement in Integration Joint Board (IJB) meetings is limited to IJB Members and professional advisors to the IJB, and officers invited to present reports. The meetings are publicised on the HSCP website to facilitate attendance of interested members of the press and public who wish to come and observe. Prior to the Covid-19 pandemic meetings took place in Commonwealth House to take advantage of a consistent and centre location that reflects the fact that a large proportion of Board Members and officers asked to provide input to specific agenda items are located or spend their working days in the city centre for business meetings, and to therefore reduce travel time for those who require to attend. This has been a useful element in ensuring the Board meetings are quorate and can carry out the necessary business of the IJB. 			access to a venue that includes adequate	
			local parking and transport links for	
			attendees, as well as meeting all the	
			required access requirements of Members	
			and observers. Commonwealth House is	
			also suitably equipped with necessary to	
			audio-visual equipment and software to	
			accommodate large meetings such as	
			microphones, tele-conferencing, video-	
			conferencing and on-screen presentations.	
			The IJB/HSCP has opted in the past not to	
			alter or rotate the venue for the IJB to	
			locations outwith the city centre to	
			promote continuity for Members and avoid	
			possible disruption and attendance/quorum	
			issues often caused by travel requirements.	
			Continuity has enabled the invitations for	
			the IJB to be issued in advance for the	
			entire year in advance without having to	
			consider or manage issues related to the	
			sudden and unexpected lack of availability	
			of other venues, or the cost or access issues	
			experienced if using multiple venues across	
			the city. It has always been felt that	
			retaining one consistent location has	
			therefore been the optimal approach to	
			holding the IJB and one which offers the	
			best opportunity for good attendance and	
			meeting the significant and evolving	
			technical considerations.

			It is acknowledged that rotation of the IJB would make IJB meetings more visible to members of the community. It is proposed therefore that on the resumption of face to face meetings once the operational consequences of the pandemic have subsided officers within the HSCP will review the availability of venues across the city to identify those which could accommodate the requirements of a meeting of the size and scale of the IJB (as referred to above) with a view to considering whether holding IJB meetings in local venues would be practical and beneficial.	·
13	I notice that the paper refers to the twenty minute neighbourhood suggestion. Is this something that could be done in partnership with local community groups?	Robert Smith	The concept of "20 minute neighbourhoods" within the Programme for Government is an ambition the Scottish Government have committed to taking forward in conjunction with local government. It is unclear at this stage how this work will be progressed or the level of involvement officers working within the HSCP will have in this work. Any activity undertaken within the HSCP in this area will be considered to ensure the appropriate levels of community engagement and consultation take place, using the engagement structures of the HSCP and in line with the Participation and Engagement Strategy.
