#### 1. Introduction

- 1.1 The Scottish Government require an Annual Report from each Community Justice Authority in respect of its delivery of Multi Agency Public Protection Arrangements. The Integrated Joint Board will be provided with this annual update on the progress and performance of the Multi Agency Public Protections Arrangements in Glasgow. - 1.2 Multi Agency Public Protection Arrangements (MAPPA) is a well established process in Glasgow which is targeted at managing the risk that registered sexual offenders and restricted patients present to communities. MAPPA brings together agencies involved in the management of registered sexual offenders and restricted patients to share information to develop risk assessment and through the appropriate use of resources, skill and expertise agree risk management plans to manage risk to the public in a co-ordinated way.
- 1.3 The report provides an assessment of how well partners achieved the objectives set out in the previous MAPPA Annual Report, and identifies the priority areas of action to improve our responses to individuals managed by MAPPA and consequently to improve our capacity to protect the public.

1.4 This annual report concludes that agencies in Glasgow continue to work well together to meet the demands of MAPPA work in Glasgow, and to collectively manage the inherent risks and challenges involved in this form of public protection. The report demonstrates that we continue to meet performance targets and that we have a clear set of agreed priorities amongst the partners.

# 2. Content of Report

- 2.1 This is the ninth annual report of the Glasgow MAPPA (Multi Agency Public Protection Arrangements). These annual reports have provided the public with an understanding of how the Multi Agency Public Protection Arrangements have worked over the years. The report provides:
  - An explanation of what MAPPA is and how Registered Sex offenders and Restricted patients are managed across 3 levels of risk
  - A set of objectives for the following year.
  - Measures performance locally and against national targets
  - An update on the National MAPPA audit (also referred to as the MAPPA Thematic Review)
  - An update on the extension to MAPPA for offenders posing a Risk of Serious Harm
  - Statistical information
  - 3 brief case studies
  - The action plan for the coming year

## 3. Performance

3.1 The report provides details of the performance on the 6 national Key Performance Indicators, and notes that Glasgow's performance is very good in this regard and provides detail of where one two indicators are less than 100%, - being 98% and 94% and the reasons for this.

# 4. MAPPA Action Plan and Accountability

- 4.1 Section 7 of the report provides the priority actions identified for progression in 2016/17. These actions reflect ongoing areas of work which strengthen the Multi Agency Public Protection Arrangements in Glasgow along with the specific points highlighted through the National Thematic MAPPA review.
- 4.2 The MAPPA Operational Group (MOG) and the Strategic Oversight Group (MAPPA SOG) monitor the progress of the action plan, and highlight any relevant issues to the quarterly meeting of the Public Protection Chief Officers Group (COG) chaired by the Council's Chief Executive.

# 5. Conclusion

- 5.1 The MAPPA Annual Report provides detail of the partner agencies activity and progress in the management of Registered Sex Offenders and Restricted Patients, and as a consequence their performance in this aspect of Public Protection.
- 5.2 The report reflects a positive picture of strong collaborative working, but also the challenging nature of this work and the need to be constantly alert to the increasingly complex nature of risk management in the context of Sex Offending.
