**1. Introduction**

1.1 The HSCP has developed three locality plans for 2019/20 the purpose of which is to:

- a) set out the demographics and health and social care needs of the local population;
- b) reflect the HSCP's priorities and actions that are relevant to the locality;
- c) demonstrate how each locality will contribute to the implementation of the IJB Strategic Plan;
- d) communicate our performance against key targets;
- e) set out the services within each locality and associated resources, including headline information on staffing, finance and accommodation; and,
- f) be a vehicle for stakeholder engagement to ensure there is effective local engagement in service planning activities.

1.2 Draft locality plans were reported to the IJB in September 2019 [<https://glasgowcity.hscp.scot/publication/item-no-12-health-and-social-care-partnership-locality-plans-2019-22>], and highlighted further engagement activity would take place before final plans were reported to the IJB in January 2020. This report updates the Committee on the activity planned in each locality over the next few months.

**2. Locality Engagement**

2.1 The draft locality plans are themselves the product of a broad range of engagement activity. This has ranged from community engagement on previous locality plans, service specific engagement events, the IJB Strategic Plan consultation and the regular locality forums and networks.

2.2 A further period of engagement will also allow services to give additional consideration to the potential to set more precise timescales to the delivery of actions. The final version of the locality plans will be brought back to the IJB for approval in January 2020.

2.3 Engagement plans in each locality include:

### 2.3.1 North East

Consultation on the NE Locality Plan is an integral part of ongoing work to ensure community participation in the development of local health and social care services. The draft Plan will be discussed at the November 2019 meeting of the NE Locality Engagement Forum and at other events as follows:

- Asylum/Refugee Event St. Mango's Museum 26/10/19.
- Public Session Third sector Community groups and service users 26/11/19

The Plan will also be circulated as an agenda item to the following groups in October/November 2019:

- NE Locality Carer's Forum
- NE Locality Older People's Planning Group
- NE Children's Services Locality Planning Group
- NE Primary Care Implementation Group
- Focus Groups NE Mental Health / Substance Misuse Recovery Groups

### 2.3.2 North West

The web link to the draft North West Locality Plan was circulated to a wide range of patient, service user, Carers groups, Community Councils, third sector and community groups along with an invite to a NW Locality engagement event held on 15 October 2019. The session generated a breadth of opinions and comments which will contribute to implementation of our Locality priorities.

The draft North West Locality Plan will also be presented to Drumchapel Thriving Places Breakfast and a Bletter on 23 October 2019 and the Possilpark and Ruchill Thriving Places Network Breakfast on 8 November 2019.

### 2.3.3 South

In South the draft has been circulated to a wide range of user and carer, and third sector groups including:

- South Locality Older People's Planning Group
- South Children's Services Locality Planning Group
- South Primary Care Implementation Group
- South GP Committee
