## 1. Purpose

- 1.1 This monitoring statement provides a summary of the financial performance of Glasgow City Integration Joint Board for the period 1 April 2019 to 30<sup>th</sup> September 2020 (Health), and to 24<sup>th</sup> September 2020 (Council).
- 1.2 It is based on information contained in the respective financial systems and includes accruals and adjustments in line with its financial policies.

## 2. Summary Position

- 2.1 Net expenditure is £4.230m lower than budget to date. Gross expenditure is £5.663m (0.91%) underspent, and income is under-recovered by £1.433m (2.38%).
- 2.2 Appendix 1 shows the current budget variance by both care group and subjective analysis.

## 3. Budget Changes

3.1 Throughout the financial year, adjustments are made to the original approved budget as a result of additional funding allocations and service developments. During Month 6/Period 7 the net expenditure budget has increased by £4.632m. The changes to the gross expenditure and income budgets are analysed in the table below.

#### 4. Transformation Programme

- 4.1 The overall savings target for 2020/21 is £13.770m. At this stage of the year it is anticipated that actual savings realised will be £7.501m representing 54% of the target. Delivery of savings has been impacted by the need to focus resources in responding to COVID-19. These are mainly linked to savings identified for the Maximising Independence Programme, Prescribing and Transport savings. Programme boards have re-commenced to support major savings initiatives, however it is anticipated that full delivery will not be achievable in 2020-21. An update on Prescribing is included at section 5.4. The tender for transport has been delayed and discussions continue with the Council to expedite this.
- 4.2 The unachieved savings target from prior years is £2.246m. At this stage of the year it is anticipated that £2.126m is forecast to be achieved, 95% of the total savings target. These are mainly linked to savings identified for the Maximising Independence Programme.
- 4.3 The savings realised are reflected in the overall financial position reported in this monitoring statement.

## 5. Reasons for Major Budget Variances

#### 5.1 Children and Families

- 5.1.1 Net expenditure is underspent by £2.195m.
- 5.1.2 Employee costs is underspent overall by £0.637m. £1.634m is due to a number of vacancies which are currently being recruited to. This is offset within Community Nursing by Health Visiting which is overspent by £0.980m as the band 7 in-post WTE is greater than the funded establishment by 37.8 WTE, together with provision made for the students in training.
- 5.1.3 Residential Schools is overspent by £0.426m, with current placements totalling 54. This represents no net movement since 1 April 2020. However there has been an increase in Secure in respect of Remand placements as a result of the pandemic.
- 5.1.4 Purchased Placements is underspent by £1.184m and is reflective of demand.
- 5.1.5 Supported Living is underspent by £0.743m mainly in respect of the new investment funding for Family Support Services where there has been a delay in the progress of tendering activity due to the pandemic.
- 5.1.6 Direct Assistance is overspent by £0.174m and relates to S22 payments.

## 5.2 Adult Services

- 5.2.1 Net expenditure is overspent by £0.142m.
- 5.2.2 Employee costs are underspent by £1.949m throughout all services due to periods of vacancies, turnover and difficulties recruiting to posts. Recruitment has been delayed due to covid19 restrictions but continues to be progressed for vacant posts in all services.
- 5.2.3 Third party costs are overspent by £1.641m attributable in the main to Learning Disabilities Purchased Services (including Self Directed Support). This is attributable to unachieved savings and the impact of transition from Children and Families, and onwards to Older People. High cost services continue to be managed via the Management and Allocation of Community Resource Options Group (MACRO.)

#### 5.3 Older People and Physical Disability

- 5.3.1 Net expenditure is underspent by £5.647m.
- 5.3.2 Employee costs are underspent by £0.880m mainly in Community Health settings, Homecare services and Hospital discharge due to staff vacancies which are currently being recruited.
- 5.3.3 Purchased care homes are underspending by £2.200m. Previously this had been included as an off-set in our returns to Scottish Government on the cost of responding to the pandemic. The Scottish Government have changed their funding arrangements, at this stage, and removed non delivery of savings and offset savings. The pandemic has had a significant impact on our assumptions, and so far year to date we have seen both a 15% increase in admissions levels, and a 68% increase in discharge levels over the same time. The increase in admissions have taken place from June onwards and the increase in discharges occurring, in the main, at the start of the year, with discharge levels now returning to normal pre-pandemic levels at this time.
- 5.3.4 Third Party Payments are underspent by £1.454m across Purchased Services in Personalisation, Supported Living, Discharge to Assess and Purchased Homecare Services and is reflective of demand. Discharge to Assess is a new service that has started but has been impacted by the pandemic.
- 5.3.5 Supplies and services are underspending by £0.557m mainly within Care Alarms services in relation to the purchase of telecare equipment and is reflective of current demand.

#### 5.4 Resources

- 5.4.1 Net expenditure is underspent by £0.715m.
- 5.4.2 Employee costs is underspent by £0.273m due to vacancies / turnover across a number of areas with recruitment to administrative posts underway.
- 5.4.3 Supplies and Services is underspent by £1.596m. The is mainly due to an underspend within Equipu, Stairlifts and Ceiling Track Hoists as less equipment is being purchased/utilised by the Equipu Partnership, primarily due to COVID-19 restrictions. This is offset by a reduction in income recoveries.
- 5.4.4 Income is under-recovered by £1.233m due to lack of activity caused by COVID-19 restrictions. This is across Stairlifts, Ceiling Track & Hoists, EquipU and Linguistics. This is reflected in the underspend in Supplies and Services.

#### 5.5 Primary Care

- 5.5.1 Primary Care is showing an underspend position of £0.416m.
- 5.5.2 Vacancies within Prescribing Support Services and Health Improvement teams is resulting in an underspend of £0.393m.
- 5.5.3 Prescribing is currently overspending by £0.015m which is summarised in the table below.

- 5.5.4 The overspend within this budget are as a result of price increases being experienced across a number of prescription drugs which are driven by pricing across a global market.
- 5.5.5 This budget area will continue to be closely monitored. At the end of the financial year the IJB earmarked £2.962m in earmarked reserves to offer a contingency in this budget due to the anticipated risk associated with pricing both during the COVID-19 pandemic and also the potential impact of BREXIT. The overspend to date can be managed within this contingency if required.

#### 5.6 Response to COVID-19

5.6.1 Funding of costs associated with COVID-19, for services delegated to the IJB, will be routed through Greater Glasgow and Clyde Health Board and passed through to the IJB to meet costs. Discussions with Scottish Government continue in relation to this funding. To date the IJB has been allocated a first tranche

payment of £11.395m to meet the initial costs of responding to COVID-19. This equates to £8.722m for social care services and £2.673m for hospices. A further allocation of £28.037m has been distributed for both health and social care services in October and will reported in the next budget monitoring report. The IJB has provided the Scottish Government with regular updates in relation to forecasted spend for all services and the cost of responding to the pandemic and this will be used by the Scottish Government in assessing future funding needs.

- 5.6.2. To date £15.290m has been spent responding to COVID-19, of which £7.884m relates to social care services and £7.406m relates to health board services. At this time £4.733m of spend relates to health services excluding hospices. This requires to be assessed against the funding which has now been made available from the Scottish Government.
- 5.6.3 The Scottish Government have given a commitment to social care providers in relation to financial sustainability during this period. The IJB is responsible for making these payments. To date Glasgow City has received 727 claims for financial sustainability for £7m. To date £3.7m has been approved and has been paid or is in the process of being paid to providers.

## 5.7 Probable Outturn

- 5.7.1 A probable outturn has been completed for the IJB. However it should be recognised that this outturn has been completed with a high level of uncertainty. The IJB continues to operate under the powers introduced by the emergency legislation in relation to Covid 19 and expect these to be in place until June next year. As a result the final position is expected to change as we continue to respond to the challenges of the pandemic over the winter months and await confirmation of future funding allocations from the Scottish Government.
- 5.7.2 An underspend of £14.3m is forecast for services excluding the costs of responding to the pandemic. The main sources of this underspend are outlined below:-
  - £7.2m across a range of services due to vacancies as a result of staff turnover and delays in recruitment. This is an improvement of 30% on last year and recognises that some improvements have been made in the last twelve months. However staff recruitment continues to represent a challenge both in terms of timescales to recruit and the availability of the skills mix required within the workforce market especially in the current pandemic. A number of actions continue to be progressed including streamlining recruitment processes, aligning recruitment timescales with the availability of newly qualified professionals, development of targeted recruitment and training strategies to develop existing and new staff to meet the skills requirements of our services.
  - £5.6m underspend within Children and Families, Adult Services and Older People Services. The pandemic has impacted on the ability of the HSCP and our providers to respond to service demand during this period. Many services have been required to prioritise service delivery to emergency only, resulting in a back log of cases which were waiting to be assessed during lockdown.

As lockdown restrictions have been eased recovery planning is underway, however it will take time to work through this recovery fully. As these services respond to the back log spend in these areas will start to increase and it will be crucial that as part of the IJB's financial planning that this funding is held in reserves to meet this demand when it comes.

- £3.8m underspend in purchased care homes places. The pandemic has had a significant impact on care homes with a 15% increase in admissions levels, but also a 68% increase in discharge levels being experienced so far this year. The increase in admissions have taken place from June onwards and the increases in discharges occurring, in the main at the start of the year, with discharge levels now returning to normal pre-pandemic levels, at this time.
- £1.4m reduction in spend on supplies and services and transport as a result of services operating at a reduced capacity during the pandemic.
- £1.4m in respect of a delay in progressing the tender activity for Family Support Services, which again has been impacted by responding to the pandemic.
- 5.7.3 The areas identified above represent an underspend of £19.4m, some of which have been off-set by the overspends being experienced as a result of the non delivery of savings (£3.5m) and the overspend in Health Visiting (£1.6m). This results in a net underspend on operational activity of £14.3m.
- 5.7.4 As outlined in section 5.6, the IJB has incurred additional costs responding to the pandemic. The total cost of this is forecast to be £58.3m for 2020-21. To date funding of £39.4m has been made available by the Scottish Government. This represents a gap in funding of £18.9m to date. The IJB continues to provide the Scottish Government with regular updates in relation to forecast spend for all services and the cost of responding to the pandemic. Indications at this stage are that further funding will be allocated in December and in the new calendar year.
- 5.7.5 In summary, the outturn position is an overspend of £4.6m and is summarised in the table below. Further allocations from the Scottish Government are anticipated, however if a shortfall remains at the end of the financial year this will require to be funded from the use of IJB general reserves. Equally if we have an underspend at the end of this financial year, this will be required to go to IJB general reserves to help to fund unachieved savings carrying forward from this year and service pressures from COVID 19 which continue into next year.

5.7.6 The overall position will continue to be kept under review and any significant changes reported as we move closer to the year end.

## 5.8 Health Board Budget Offer 2020/21

- 5.8.1 On 25 March 2020, the IJB agreed to conditionally accept the indicative funding offer from NHS Greater Glasgow and Clyde for 2020-21, subject to confirmation in April 2020.
- 5.8.2 A letter has now been received confirming the final budget offer which was approved by the Board of NHS Greater Glasgow and Clyde on 2 November and reflects the indicative offer made to the IJB in March. This letter is contained in Appendix 2.

#### 6. Action

6.1 The Interim Chief Officer, along with the Health and Social Care Partnership Senior Management Team, continues to manage and review the budget across all areas of the Partnership.

#### 7. Conclusion

- 7.1 Net expenditure is £4.230m lower than budget to date.
- 7.2 A number of savings initiatives through the transformation programme have yet to achieve the required level of savings. These initiatives are being critically reviewed and closely monitored by the IJB's Integration Transformation Board.

#### 8. Recommendations

- 8.1 The Integration Joint Board is asked to:

#### 2020/21 Financial Allocation to Glasgow Health and Social Care Partnership

Further to my letter in March I can now confirm the Board's allocation to the HSCP for 2020/21.

#### Annual uplift to NHSGGC

The annual general uplift is provided by the Scottish Government to support Boards in meeting expected additional costs related to pay, supplies (which includes prescribing growth and utilities charges) and capital charges. The Board's uplift for 2020/21 is 3.0% totalling £68.9m.

#### The HSCP Settlement

The Scottish Government's funding allocation letter issued on 6 February 2020 states that "In 2020-21, NHS payments to Integration Authorities for delegated health functions must deliver an uplift of at least 3.0% over 2019/20 agreed recurring budgets".

The total allocation uplift to all six HSCPs should therefore be £25.6m based on the recurring budget at 31 March 2020 and the partnership's share of this allocation is included in **Appendix 1**. Appendix 1 also includes the uplift allocation for Specialist Childrens Serviced managed by the HSCP.

#### Set Aside Budget

During 2019/20 work has continued to identify the actual budgets and costs of unscheduled care services and these have been used as the basis for the set aside allocation for 2020/21. This is based on the final out-turn for 2019/20 uplifted by 3.0%. This figure represents the estimated actual usage of in scope Acute services. This will continue to be a notional allocation until commissioning plans are in place between HSCPs and the Board.

#### **Recharges to HSCPs**

The following items will continue to be charged to the HSCP during 2020/21:

- The HSCP's proportional share of the Apprenticeship Levy based on your HSCP's payroll cost; and
- The HSCP's proportional share of the annual cost arising from the change in accounting treatment of pre 2010 pension costs as the non recurring funding generated from this change was used to provide non recurrent support to all service areas in 2016/17.

Non recurring allocations including Scottish Government allocations for COVID-19 for both health and social care expenditure will be passed directly to the partnership when received by the Board.
