NATIONAL CARE HOME CONTRACT SETTLEMENT (2019/20)

Purpose of Report:	The purpose of this report is to update the Integration Joint Board on a one year National Care Home Contract (NCHC) settlement for 2019/20 and the commitments within the contract in relation to the Scottish Living Wage.		
Background/Engagement:	The NCHC is a national contract which is negotiated across Scotland and full engagement of Scottish Councils via COSLA.		
Recommendations:	The Integration Joint Board is asked to: a) note the increased rates from 8 April 2019 as outlined in Appendix 1; b) agree to allocate £2.608m to pay for the care home fees uplift and Scottish Living Wage settlement and amending the budget allocation for demographic pressures to £8.190m; and c) instruct the council to vary the contracts with providers in line with the conditions at 4.3.		

Relevance to Integration Joint Board Strategic Plan:

The delivery of good health and social care outcomes is dependent on the quality of care delivered by providers with whom we contract. This offer improves conditions for staff and organisations and should contribute to improved health and wellbeing outcomes for staff and service users.

1. Purpose

1.1 The purpose of this report is to update the Integration Joint Board on a one year National Care Home Contract (NCHC) settlement for 2019/20 and the commitments within the contract in relation to the Scottish Living Wage.

2. Background

2.1. The NCHC is subject to national negotiation. This negotiation sets the rates which will apply for 2019/20 and also the expectations in relation to the payment of Scottish Living Wage by providers.

3. Implications of 2019/20 fee uplift

- 3.1 The rates attached at Appendix 1 are applicable from 8 April 2019. A rate of 3.65% has been applied to nursing care and 3.40% for residential care.
- The cost of the uplift of £2.608m will be funded by the additional monies provided to integration authorities in 2019/20 for social care.
- 3.3 The IJB in March agreed a provisional budget for contractual inflation which included a provision of £2.352m for the National Care Home contract. This report recommends that this is now increased by £0.256m to match the cost identified at 3.2. As a result the budget now available for demographic pressures will now be reduced from £8.446m to £8.190m.

4. Scottish Living Wage

- 4.1 The NCHC financial settlement for 2019/20 requires all providers delivering publicly funded care to pay all care workers, regardless of age, experience or time in employment, a minimum of £9.00 by 1st May 2019.
- 4.2 The contract also commits providers employing registered nurses and delivering publicly funded care to pay nurses on average Agenda for Change band 5.
- 4.3 On this basis the National Care Home Contract will be varied to ensure:
 - Any provider delivering publicly funded care must pay all care workers a minimum of £9.00;
 - Any provider delivering publicly funded care must pay registered nursing staff on average Agenda for Change band 5;
 - Providers agree that remuneration can be periodically monitored by the commissioning authority, including direct verification with employees of the provider;
 - There will be no displacement of other costs onto staff by the employer.

5. Recommendations

- 5.1 The Integration Joint Board is asked to:
 - a) note the increased rates from 8 April 2019 as outlined in Appendix 1;
 - b) agree to allocate £2.608m to pay for the care home fees uplift and Scottish Living Wage settlement and amending the budget allocation for demographic pressures to £8.190m; and
 - c) Instruct the council to vary the contracts with providers in line with the conditions at 4.3.
