**Glasgow City HSCP COVID-19 Communications Survey 2021**

**Purpose of Report:** The purpose of this report is to summarise the findings from Glasgow City Health and Social Care Partnership's (HSCP) COVID-19 Communications Survey in March 2021, and to present the HSCP's new Partnership Matters Briefing based on feedback from the survey.

**Background/Engagement:** The COVID-19 pandemic has been the focus and priority for HSCP communications over the past year. Extensive communications support has been provided to the HSCP's service contingency and renewal/recovery planning arrangements and responses to COVID-19 to keep a range of internal and external stakeholders up to date and informed.

The easing of Scotland's recent national lockdown to the previous levels systems has provided the opportunity for the HSCP to review the main ways in which it has communicated with staff, Integration Joint Board (IJB) Members and Council Elected Members to date, and how it continues in the next phase of the pandemic and post-COVID-19.

At its meeting in 18 March 2021, the HSCP's Executive Group requested that a survey be undertaken to inform this, which took place over a two-week period at the end of March/beginning of April. Findings from the survey and a proposal for a new HSCP briefing, titled 'Partnership Matters', were approved by the Executive Group at its 26 April meeting.

### 1. Purpose

- 1.1 The purpose of this report is to summarise the findings from Glasgow City Health and Social Care Partnership's (HSCP) COVID-19 Communications Survey in March 2021, and to present the HSCP's new Partnership Matters Briefing based on feedback from the survey.

### 2. Background

- 2.1 The COVID-19 pandemic has been the focus and priority for HSCP communications over the past year. Extensive communications support has been provided to the HSCP's service contingency and renewal/recovery planning arrangements and responses to COVID-19 to keep a range of internal and external stakeholders up to date and informed. Communications is a critical business support function for the HSCP, and HSCP communications are underpinned by the HSCP's second [Communications Strategy](#) that was approved by the Glasgow City Integration Joint Board (IJB) in September 2020.
- 2.2 The development of the HSCP's ICT capability during the COVID-19 pandemic, along with the increased use of digital and social media channels by people and organisations to get their information from, has presented opportunities for the HSCP to improve and innovate the ways in which it communicates through the use of branded email templates, branded briefings, motion graphics, videos, websites and digital and social media channels such as Twitter and YouTube.
- 2.3 Throughout the COVID-19 pandemic, the HSCP has been regularly communicating with internal and external stakeholders through a number of channels. The main ones have included:
- regular email communications
  - the COVID-19 briefing including open and closed buildings
  - video messages from HSCP Senior Management Team Members
  - dedicated briefings for specific service areas
  - a dedicated webpage on the HSCP's website

- staff briefings and motion graphics to support HSCP staff in their jobs
- posters for HSCP buildings to ensure compliance with Government and Public Health COVID-19 guidelines and to support a safe service delivery environment and
- a number of videos to support the health and safety of staff, including their health and wellbeing, also published on the HSCP's YouTube channel.

2.4 The easing of Scotland's recent national lockdown to the previous levels systems has provided the opportunity for the HSCP to review the main ways in which it has communicated with staff, IJB Members and Council Elected Members to date, and how it continues in the next phase of the pandemic and post-COVID-19.

2.5 At its meeting in 18 March 2021, the HSCP's Executive Group requested that a survey be undertaken to inform this, which took place over a two-week period at the end of March/beginning of April. Findings from the survey and a proposal for a new HSCP briefing were approved by the Executive Group at its 26 April meeting.

### 3. HSCP COVID-19 Communications Survey

3.1 A communications survey was developed for HSCP staff, IJB Members and Council Elected Members to share their views on:

- the main ways in which the HSCP has communicated with them throughout the COVID-19 pandemic to date, including the usefulness of email communications, the COVID-19 briefing, specific briefings to support staff in their job and SMT videos
- the future frequency of the COVID-19 briefing
- whether they would find service updates in future communications useful and their frequency and
- any suggestions or comments about HSCP COVID-19 communications.

3.2 The survey was web-based and open over a two-week period at the end of March into April 2021. The survey was promoted through email communications and the COVID-19 briefing. Additionally, HSCP Care at Home staff received an SMS text message to their work smartphones inviting them to participate in the survey, and the survey web link was enabled for them to complete the survey via their work smartphones.

3.3 Full results to the survey are attached as Appendix A.

3.4 Summary highlights from the survey include:

- 946 people participated in the survey, mainly consisting of staff (930, 98.3%)
- HSCP staff across all service areas participated, with higher number of participants from Care at Home Services (210, 22.6%); Finance and Resources (160, 17.2%); Children's Services (135, 14.5%); Older People's Services (126, 13.6%) and Adult Services (116, 12.5%)
- 9 in 10 (842, 89%) respondents found HSCP email communications useful/very useful, and just under 1 in 10 (83, 8.8%) found them a little useful

- just under 9 in 10 (829, 87.6%) respondents found the HSCP's COVID-19 briefing useful/very useful, and 1 in 10 (97, 10.3%) found it a little useful
- the majority of respondents, 3 in 5 (558, 59%), thought that the frequency of the HSCP's COVID-19 briefing should be reduced: monthly (494, 52.2%); bimonthly (55, 5.8%) and quarterly (9, 1%)
- over 9 in 10 (886, 93.7%) respondents thought that a service briefing post-COVID-19 would be useful. Of those who thought it would be useful, half (452, 51%) thought that its frequency should be monthly, whereas the other half (434, 49%) thought it should be less frequent, bimonthly (230, 26%) and quarterly (204, 23%)
- 929 HSCP staff rated the HSCP briefings to support them in their jobs. 4 in 5 (749, 80.6%) respondents found them useful/very useful, and an eighth (117, 12.6%) found them a little useful
- 7 in 10 (657, 69.5%) respondents found the SMT videos published alongside the COVID-19 briefing useful/very useful, and an eighth (114, 12.1%) found them a little useful and
- around 90 respondents provided a comment/suggestion that related to HSCP COVID-19 communications. Some comments / suggestions included reducing the COVID-19 briefing but including other updates on work happening across the HSCP; reducing web links where possible in briefings and making briefings available in PDF format so that they can be printed; using more videos and graphics to communicate and incorporating hyperlinks in COVID-19 briefings to 'jump to' service-specific updates.

### 4. Partnership Matters Briefing

- 4.1 Based on feedback from the COVID-19 Communications Survey, the following new briefing has been developed and approved by the HSCP's Executive Group for HSCP communications in the next phase of the COVID-19 pandemic and post-COVID-19. A mock example is attached as Appendix B.
- 4.2 The HSCP's COVID-19 briefing will continue but will now be reported as part of a regular HSCP briefing to keep a range of internal and external stakeholders updated on some of the key work happening across the HSCP with partners.
- 4.3 The briefing will be titled 'Partnership Matters Briefing' to reflect the partnership approach and arrangements for the planning and delivery of health and social care within Glasgow City, and it will include:
  - 2-5 key updates and announcements that can include:
    - messages from the SMT
    - SMT/Lead appointments
    - service-specific updates, whether about current services or service developments
    - key IJB and IJB Committee reports
    - building updates (e.g., capital builds and relocation of services)
    - consultations and engagement opportunities
    - business continuity updates
    - COVID-19 announcements
    - campaigns
    - national days and
    - awards

- COVID-19 update including:
  - the HSCP's COVID-19 briefing with service updates
  - hyperlink to the HSCP's COVID-19 webpage with the open and closed HSCP buildings briefing and further hyperlinks to national and local information relating to COVID-19
- videos featuring Senior Management Team Members in the short-term moving to ones in the medium- to long-term that feature the work of service areas and staff teams across the HSCP
- news articles and briefings/bulletins available on the HSCP's website and
- HSCP meetings and events that are upcoming.

4.4 The briefing will be initially published monthly, with its on-going frequency possibly reduced post-COVID.

4.5 The briefing will be issued via email to HSCP staff, IJB Members, Council Elected Members and GP Practices. Further work will be progressed to issue it to other stakeholders such as health and social care contractors/providers, Community Councils and third sector groups/networks such as the Glasgow Council for the Voluntary Sector, Glasgow Disability Alliance, Glasgow Centre for Inclusive Living, Glasgow Equality Forum and Volunteer Glasgow.

4.6 The first edition of the briefing is planned for the end of May 2021.



### Glasgow City Integration Joint Board (IJB) Budget for 2021 – 22

The IJB recently approved its budget for the delivery of health and social care services for 2021 – 22, with funding offers from Glasgow City Council and NHS Greater Glasgow and Clyde. This will see a budget of around £1.4b from the parent organisations being spent on the delivery of services, and includes additional in-year investment in the real Living Wage, uprating of free personal and nursing care payments and continued implementation of the Carers Act. A number of pressures were identified with a spending gap of around £5.9m, which will be funded by a savings programme. [You can read the full report.](#)
