### UPDATE ON SUSTAINABLE SOLUTION FOR HOMECARE SERVICES FOR 2019-20

**Purpose of Report:** This report provides an update on the funding for Homecare.

**Background/Engagement:** On [27 March 2019](#), the IJB agreed to accept Glasgow City Council's funding offer, subject to the joint development of a financially sustainable solution for both Homecare and Housing First by September 2019.

**Recommendations:** The Integration Joint Board is asked to:

- a) note the update provided in relation to Homecare Services and the delivery of a jointly developed financially sustainable solution for Homecare Services; and
- b) accept the funding offered by the Council in relation to both 2019-20 and recurringly from 2020-21 for Homecare Services.

### 1. Purpose

- 1.1 This report provides an update on the funding for Homecare for 2019-20.

### 2. Background

- 2.1 On 27 March 2019, the IJB agreed to accept Glasgow City Council's funding offer, subject to the joint development of a financially sustainable solution for both Homecare and Housing First by September 2019. The IJB was provided with an update on [26 June 2019](#) and on the [18 September 2019](#). This report provides a further update on Homecare.

### 3. Homecare Services

- 3.1 In September 2018, the IJB received an update from the Council in relation to the funding for Homecare Services. This reiterated their commitment to finding a financial solution both for 2019/20 and future years. However at that point it was not in a position to confirm the details of a funding offer for 2019/20 until the City Administration Committee had considered this on 26 September 2019.
- 3.2 The City Administration Committee has subsequently met on 26 September 2019 and agreed to jointly fund the £4.7m deficit estimated for 2019-20, with £2.35 million from the Council and £2.35 million funded from the IJB. The City Administration Committee has also agreed to add this funding to the base budget for future years. See revised offer letter attached at Appendix 1.
- 3.3 The IJB's funding contribution of £2.35 million will be funded from within the IJB's budget for 2019-20.
- 3.4 In addition to the recurring deficit, Homecare Services have incurred additional costs associated with the contingency arrangements required to be put in place to manage the potential implications to staffing levels following the settlement of the Council's equal pay dispute. Funding of £450,000 has also been provided to meet these costs.

### 4. Recommendations

- 4.1 The Integration Joint Board is asked to:
- a) note the update provided in relation to Homecare Services and the delivery of a jointly developed financially sustainable solution for Homecare Services; and
  - b) accept the funding offered by the Council in relation to both 2019-20 and recurrently from 2020-21 for Homecare Services.

Dear Sharon

Further to my letter to you on 27<sup>th</sup> August 2019. I can now confirm that the City Administration Committee on 26<sup>th</sup> September approved that they would provide funding to cover 50% of the overspend on homecare. This is currently estimated as a contribution of £2.35m for 2019/20. I can also confirm that this will be baselined for future year's budgets.

I can also confirm that Glasgow City Council will provide funding of £450k to cover the additional costs incurred as a result of contingency planning in relation to equal pay.
