#### 1. Purpose

1.1 To provide an update on and seek approval for a number of appointments to the IJB and its committees and to agree the Terms of Reference for the IJB Finance, Audit and Scrutiny Committee.

#### 2. Background

- 2.1 The IJB in September 2018 noted that stakeholder members representing patients, service users, the third sector and the independent sector were all nearing the end of their initial three year term as IJB members, and agreed that the Chief Officer should contact relevant stakeholder groups to either confirm that the current members should remain on the IJB for a further term, or to identify new nominees.
- 2.2 In addition, Dr Michael Smith, who is appointed to the IJB by NHS Greater Glasgow and Clyde representing clinicians not involved in Primary Care, is also reaching the end of his initial three year term.
- 2.3 Sheena Wright has served as Interim Nurse Director at recent IJB meetings, but ceased to do so at the end of 2018, and the post has subsequently been filled by Julia Egan, who will serve on the IJB.
- 2.4 At the time of the September 2018 paper, there was a vacancy on the IJB for a carer representative, recruitment of Glasgow City Council's Carers' Champion still being ongoing. The recruitment of Glasgow City Council's Carers' Champion has now concluded with discussion ongoing regarding whether the Carers Champion(s) will accept the invitation to join the IJB.
- 2.5 At the IJB in December 2018 Board members requested that an approach be made to Glasgow Equality Forum to seek a representative to appoint as an advisory member on the IJB Public Engagement Committee.
- 2.6 At the IJB in December a paper was agreed that recommended discontinuing the IJB Performance Scrutiny Committee and the move of the relevant agenda items to the IJB Finance and Audit Committee, to be renamed IJB Finance, Audit and Scrutiny Committee.

#### 3. Committee Membership

3.1 Locality Engagement Forums were tasked with co-ordinating a process to identify interested parties for the health care and social care stakeholder roles with nominations submitted to Business Development staff. The nominations were reviewed by David Williams, Chief Officer, on the basis of their supporting statements and volume of nominations. Representatives for the third and independent sector were sought by nominations via established engagement channels. Subsequently the following individuals are nominated for membership of the IJB for a further three years, and require IJB approval:

- 3.2 In addition to the nominations for health care and social care user representatives there was an expression of interest from one other individual. Staff representing the HSCP are actively engaging with this individual to discuss ways they could become meaningfully involved in the activity of the IJB/HSCP.
- 3.3 Representatives of the IJB have been in discussions with newly appointed Carers Champions to consider taking up the role of carer representatives on the IJB and it is hoped that a decision on this will be made in time for the IJB in March.
- 3.4 NHS Greater Glasgow and Clyde have confirmed that Dr Michael Smith shall remain a member of the IJB representing clinicians not involved in Primary Care. The health board have also appointed Julia Egan to the IJB as the representative from nursing. Both appointments are a matter for the health board and do not require IJB approval, and are therefore for noting only.
- 3.5 It is further confirmed that, following the completion of her term as Chair of the IJB (on 8<sup>th</sup> February 2019), Councillor Hunter will revert back to Vice Chair. Simon Carr will take up the role of the Chair from 8<sup>th</sup> February 2019 for one year.
- 3.6 Following contact with Glasgow Equality Forum, it is proposed that Lorraine Barrie, manager of Glasgow Equality Forum, be co-opted to the IJB Public Engagement Committee as an equalities advisor, to provide a link between the committee and a wide range of equalities networks across the city.
- 3.7 Due to the departure of Stuart Donald from GCHSCP, Craig Cowan will undertake the role of the substitute for the Standards Officer.

#### 4. Committee Appointments

4.1 As per regulations and the IJB's own Standing Orders, appointment of members to IJB Committees is a matter for the IJB itself. Following the process of identifying proposed stakeholder members of the IJB and discussions regarding existing vacancies on the IJB's Committees, the proposed committee membership (subject to approval at 3.1) is as follows:

# **TERMS OF REFERENCE**

#### **Composition:**

6 Voting Members of the IJB (3:3) plus 2 Non-Voting Members Chair and Vice Chair must be a Non-Executive Member of the Board or Councillor who is not Chair or Vice Chair of the IJB

#### Frequency:

6 meetings per year

#### Purpose:

The IJB Finance, Audit and Scrutiny Committee is responsible for monitoring the financial and operational performance of the Glasgow City Health and Social Care Partnership; reviewing audit and inspection reports; promoting the observance of high standards of financial propriety; and for receiving updates on and scrutinising progress with key pieces of work across the Health and Social Care system.

#### Remit:

- Monitoring internal financial control, ensuring that appropriate financial controls are in place
- Ensuring that performance is monitored against budget and that the budget plan is clearly linked to the strategic plan
- Endorsement of capital schemes promoted by the parent bodies
- Approval of the annual audit plan

- Initiating and undertaking specific audits and/or reviews of any matters falling within the remit of the committee or requested by the Integration Joint Board
- Receiving and considering summaries of internal and external audit reports which relate to any issue falling within the remit of the Integration Joint Board
- Reviewing reports of external inspections of health and social care services and facilities within Glasgow City
- Promoting value for money studies and best value
- Taking an overview of the Integration Joint Board's Transformational Change programmes
- Review of Risk Registers
- Referring back to the Integration Joint Board for its consideration any Service/Financial performance issue which might have implications for policy development coming within the remit of the Integration Joint Board
- Approval of the Annual Accounts and Annual Governance Statement prior to presentation to the Integration Joint Board
- To consider the external auditor's annual letter and associated reports and to report on these to the IJB
- To advise on the effectiveness of relationships between external and internal audit and other inspection agencies
- Review of the Quarterly Professional and Clinical Governance Statement and outputs from the IJB Professional and Clinical Governance Board
- Maintain oversight of the Health and Social Care Partnership's performance in statutory functions such as complaints handling, Freedom of Information and Participation Requests
- Monitor progress and review updates on various pieces of work across the Health and Social Care system on behalf of the IJB.
