Enhanced Community Living for Adults with a Learning Disability

Purpose of Report:

To advise IJB members that an opportunity has arisen to purchase accommodation within which to deliver an enhanced community living service for adults with a learning disability. This opportunity has arisen due to the allocation of GCHSCP's share of national Community Living Change Funds.

GCHSCP proposes to purchase and refurbish NHS vacant accommodation at Waterloo Close, Kirkintilloch which previously accommodated patients with a learning disability. We are also in negotiation with NHSGGC on the potential to purchase a second building, again to provide an enhanced community living service for adults with a learning disability.

GCHSCP will develop a specification for the enhanced community living service and, through a tendering process, secure the services for an adult social care provider(s) to deliver that service, from the aforementioned accommodation, for adults with a learning disability.

The aforementioned proposal represents a change to the commissioning of a specialist care home for this client group, previously recommended to IJB members. Accordingly, GCHSCP proposes to cease work on that model of care and withdraw the intention to tender for that service.

Background/Engagement:	<p>In November 2018, the IJB issued a direction to the Council to proceed with an open tender for a 15 person specialist care home for adults with a learning disability.</p> <p>IJB members received further updates in June and September 2019. Following IJB approval, a recommendation will be made to Glasgow City Council to purchase the properties on behalf of GCHSCP;b) note the intention to stand-down work relating to the development of a specialist care home for that client group; andc) note the intention to continue working closely with key stakeholders on the proposal, including service users, families and carers and to secure a service provider(s) through a tendering process.

Relevance to Integration Joint Board Strategic Plan:

The development of such services for adults with learning disabilities aligns with the aspiration of the Partnership to deliver support at the right time, in the right place, and from the right person, and to provide health and social care services in local communities, where possible. It will also enhance GCHSCPs ability to provide alternative pathways to prevent hospital admission and support the Partnership's key priorities of shifting the balance of care and enabling independent living for longer.

Provider Organisations:	The project will include a formal engagement with the Learning Disability Provider marketplace.
Equalities:	An Equalities Impact Assessment was previously undertaken. Notwithstanding that, the content of that EQIA will be revisited and refreshed as necessary as part of the development of the new service specification.
Fairer Scotland Compliance:	The development of a community based alternative to long stay hospital admission is consistent with the IJB's duty to tackle socio-economic disadvantage.
Financial:	The annual recurring cost of the service will be met from Health Board Resource Transfer available for Long Stay Tier 4 patients, as well as from personalisation budgets. The cost of purchasing the accommodation will be met from GCHSCPs share of national Community Living Change Funds.
Legal:	The procurement exercise for care services will be carried out in accordance with the Standing Orders Relating to Contracts 2017 and the Public Contract (Scotland) Regulations 2015 and advice from the Executive Director of Corporate Services.
Economic Impact:	The commissioning of this provider-led service is a service development and will therefore have a positive economic benefit. Likewise, the re-utilisation of existing accommodation has positive benefits for the surrounding neighbourhood.
Sustainability:	The project will require to be delivered by a provider(s) experienced in supporting people assessed as requiring specialist care, and which can demonstrate positive experience and commitment to appropriate, person-centred and value based approaches to challenging behaviour. In order to be sustainable, the service will require robust, planned and proactive in-reach support from a range of health practitioners. Robust care and contract management will also be key to the success of the service. The contract price will reflect market rates for similar services.

<p>Risk Implications:</p>	<p>It is considered that the proposed service offers greater continuity of care for existing patients compared to the care home model proposed previously. As such, this should help to reduce the potential risk of placement breakdown. In addition, the move to an enhanced community living environment should hopefully reduce anxieties expressed by some families and other key stakeholders that the previous specialist care home model may compromise efforts to ensure independent living opportunities for service users are maximised.</p> <p>While much progress has been made system-wide to improve the prospect of successful discharge from NHS inpatient beds, challenges remain. GCHSCP is a committed partner to the work led by East Renfrewshire HSCP to explore how we can strengthen community services to both reduce the potential for admission and facilitate discharge. The enhanced supporting living service will contribute towards that goal and in doing so, help to reduce the risk of people being delayed in a care setting that does not meet their assessed needs.</p>

1. Purpose

- 1.1. To advise IJB members that an opportunity has arisen to purchase accommodation within which to deliver an enhanced community living service for adults with a learning disability. This opportunity has arisen due to the allocation of GCHSCP's share of national Community Living Change Funds.
- 1.2. GCHSCP proposes to purchase NHSGGC vacant accommodation at Waterloo Close, Kirkintilloch, which previously accommodated learning disability patients. The accommodation comprises of two bungalows at Waterloo Close and will be modernized to a high standard, comparable to the standard of accommodation that would have been sought in the care home model proposed previously.
- 1.3. The interior design of the bungalows will be informed by the output from engagement and consultation work to date; they will each consist of a shared living model, with each person having their own en-suite bedroom, sufficient space for visitors and access to high standard communal areas, including daily living, kitchen and dining areas, and recreation space. It is envisaged that the bungalows will each support 4 people.
- 1.4. In addition, we are in negotiation with NHSGGC on the potential to purchase a second building in the City to provide a further 4 places for similar patients with a learning disability.
- 1.5. GCHSCP will develop a specification for the enhanced community living service and, through a tendering process, secure the services for an adult social care provider(s) to deliver that service from the aforementioned accommodation for adults with a learning disability. The tendering programme will be designed to include service user and carer involvement as active participants in the process.
- 1.6. The successful provider(s) will have a proven track record in delivering excellence in service provision and be able to demonstrate innovation and best practice in relation to support for people with a learning disability. They will also ensure the involvement of service users, families, carers and guardians in the design and delivery process for this service. All providers participating in the tender will also be required to demonstrate how they propose to engage with service users, carers, guardians and advocates in monitoring service quality on an ongoing basis. Officers are confident that there are a number of experienced third and independent sector providers who would be interested in this opportunity.
- 1.7. The aforementioned proposal represents a change to commissioning a specialist care home for this client group, previously recommended to IJB members. Accordingly, GCHSCP proposes to cease work on that model of care and withdraw the intention to tender for that service.

2. Background

- 2.1. In November 2018, the IJB issued a direction to the Council to proceed with an open tender for a 15 person specialist care home for adults with a learning disability, and to provide an options paper back to the IJB once the procurement exercise was completed. In doing so, it is acknowledged that a number of concerns were expressed around the proposed care home model of service.
- 2.2. IJB members received further updates in June and September 2019. The latter meeting informed IJB members of a consultation with key stakeholders and of a commitment to a co-production approach with service users, families and legal proxies. That commitment remains and further engagement will take place in the coming months regarding the new model of care now proposed.
- 2.3. On 24th March 2021, the Scottish Government announced the release of a national £20m Community Living Change Fund aimed at supporting the redesign of services for people with complex needs, including those with a learning disability; reducing delayed discharges of people with complex needs; and repatriating people placed inappropriately outside Scotland. The Change Fund is required to be utilised within a 3 year period. Glasgow City's share of funding is approximately £2.7m.
- 2.4. Led by East Renfrewshire HSCP, the host authority for learning disability inpatient services, it has been agreed to establish a programme board across GG&C HSCPs to work collaboratively to achieve the aspirations of the Change Fund and oversee service redesign activities. This will include inpatient redesign and increasing resilience of community teams and commissioned services to improve pathways and sustain community placements. The proposal to develop and enhanced community living service is consistent with those aims and the Board-wide strategy to resettle people from NHS long stay beds and close those facilities.

3. Enhanced Community Living Service

- 3.1 An enhanced community living service for people with a learning disability aims to provide an intermediate bridge in service provision between those people assessed as suitable for discharge from NHS hospital care, but for whom existing community accommodation is at present unlikely to be a suitable or sustainable option.
- 3.2 We acknowledge that for some individuals who will transferring to the new service from NHS long stay beds, the prospect of discharge to a lower tier community service may be unlikely. Notwithstanding that, the ethos of the new service will very much be to support individuals to reach a stage when a more independent form of community provision can be considered. As well as the expertise of the social care provider, people will benefit from in-reach from healthcare professionals.

- 3.3 In particular, the enhanced community living service will aim to:
- Support individuals in positive ways.
 - Help people to find good and safe ways to manage their challenging behaviours.
 - Help people to develop independent living skills and self-management skills.
 - Over time, support people to move on to less intensive services, such as supported living, wherever possible and in line with assessed need.
- 3.4 The new facilities will be refurbished and modernized to a very high quality, providing a safe, homely environment, tailored to meet individual's need. As described in paragraph 1.3, each person will have their own en-suite bedroom, have sufficient space for visitors and have access to high standard communal areas, including daily living, kitchen and dining areas, as well as recreation space. As part of the refurbishment, the potential will also be explored to introduce technology care solutions that better support independent living and enhance the environment.
- 3.5 It is anticipated that the new service will be operational by the end of 2022. A definitive date will be firmed up once there is further clarification on the refurbishment programme and timescales for delivery.
- 4. Recommendations**
- 4.1. The Integration Joint Board is asked to:
- a) approve the decision to purchase accommodation at Waterloo Close and to refurbish it fully to provide enhanced community living for adults with a learning disability. Following IJB approval, a recommendation will be made to Glasgow City Council to purchase the properties on behalf of GCHSCP;
 - b) note the intention to stand-down work relating to the development of a specialist care home for that client group; and
 - c) note the intention to continue working closely with key stakeholders on the proposal, including service users, families and carers, and to secure a service provider(s) through a tendering process.
