| Provider Organisations: | <p>The IJB is required to include a representative from the Third Sector amongst its membership.</p> <p>While there is no legal requirement to include a representative from the Independent Sector, the IJB agreed at its first meeting in February 2016 that a member should be appointed from the Independent Sector.</p> |
| Equalities: | The IJB Public Engagement Committee includes an Equalities Advisor representative as a Non-Voting Member. |

| Legal: | Membership of the IJB is required to meet the requirements defined by the legislation. |

| Sustainable Procurement and Article 19: | None. |
| Risk Implications: | Failure to ensure appropriate Member representation on the IJB would place the IJB in breach of its statutory duties and Standing Orders, and risk the IJB not being able to conduct its business. |
| Implications for Glasgow City Council: | In addition to the appointment of councillors as voting members of the IJB the Council is required under the Social Work (Scotland) Act 1968 to have in place a Chief Social Work Officer (CSWO), who becomes a member of the IJB by virtue of that appointment. There is no term limit for the CSWO's membership of the IJB as it is linked to their tenure as CSWO. |
| Implications for NHS Greater Glasgow & Clyde: | NHS Greater Glasgow and Clyde are required to appoint members representing Primary Care, other clinicians and nursing who may serve up to three years on the IJB and can be reappointed for further terms. |

1. Purpose

- 1.1 To provide an update on and seek approval for a number of appointments to the IJB and its committees.

2. Background

- 2.1 The NHS GG&C Board Meeting of 30 June 2020 agreed changes to the allocation of Board Members to Integration Joint Boards. The Council meeting of 30 July 2020 also agreed changes to the membership of Glasgow City IJB. In addition changes are required to the membership of the IJB to reflect the retirement of IJB Members.
- 2.2 Ross Finnie and Jeanette Donnelly have ended their term on NHS GG&C and have therefore resigned their posts as Voting Members of the IJB, and subsequently the IJB Finance, Audit and Scrutiny Committee. The departure of Ross Finnie has also created a vacancy for Vice Chair of the IJB Finance, Audit and Scrutiny Committee.
- 2.3 Jacqueline Forbes is no longer a member of Glasgow City IJB and subsequently is no longer a voting member of the IJB Public Engagement Committee.
- 2.4 Councillor Tony Curtis is no longer a member of Glasgow City IJB and subsequently is no longer a voting member of the IJB Finance, Audit and Scrutiny Committee.
- 2.5 John Matthews two year term as Chair of IJB Public Engagement Committee has ended. The position of Chair requires to be filled by an IJB Council Voting Member who is member of that committee.
- 2.6 Dr. John Nugent has retired from public service and is therefore no longer a Non-Voting Member of the IJB as Clinical Director.
