1. Purpose of Report

1.1 The purpose of this report is to update the IJB on the increased uplift to the one-year National Care Home Contract (NCHC) settlement for 2021/22 and the commitments within the contract in relation to the NHS pay settlement and the proposed increases on our other commissioned services.

2. Background

- 2.1 The NCHC is subject to national negotiation. This negotiation sets the rates which will apply for 2021/22 and also the expectations in relation to the payment of Living Wage and Agenda for Change by providers.
- 2.2 On <u>5th May 2021</u> the IJB agreed to apply an uplift rate of 3% to nursing care and 2.83% to residential care. These rates were applied to both NCHC and the other commissioned services included in Appendix 1 to the report.
- 2.3 As advised at 5.1 of the report, a commitment was made from Scotland Excel and COSLA Leaders to revisit the agreed care home rate within the 2021/22 financial year when the NHS uplift for 2021/22 had been agreed.

3. Implications of 2021/22 fee uplift

- 3.1 To reflect the increase in the pay settlement for registered nurses, the nursing rate has been increased to 3.2%, there is no increase to the residential rate which remains at 2.83%. The increased rates attached at Appendix 1 are applicable from 12 April 2021 and will be applied to both the NCHC and the other commissioned services which are included at Appendix 1.
- 3.2 The cost of the additional uplift is £0.153m.

4. Agenda for Change

4.1 The updated NCHC settlement for 2021/22 requires all providers employing registered nurses and delivering publicly funded care to pay nursing staff the increased pay settlement of 4% from 12 April 2021.

1. Purpose

2. Background

- 2.1. The NCHC is subject to national negotiation. This negotiation sets the rates which will apply for 2021/22 and also the expectations in relation to the payment of Living Wage and Agenda for Change by providers.
- 2.2 On <u>5th May 2021</u> the IJB agreed to apply an uplift rate of 3% to nursing care and 2.83% to residential care. These rates were applied to both NCHC and the other commissioned services included in Appendix 1 to the report.
- 2.3 As advised at 5.1 of the report, a commitment was made from Scotland Excel and COSLA Leaders to revisit the agreed care home rate within the 2021/22 financial year when the NHS uplift for 2021/22 had been agreed.

3. Implications of 2021/22 fee uplift

- 3.1 To reflect the increase in the pay settlement for registered nurses, the nursing rate has been increased to 3.2%, there is no increase to the residential rate which remains at 2.83%. The increased rates attached at Appendix 1 are applicable from 12 April 2021 and will be applied to both the NCHC and the other commissioned services which are included at Appendix 1.
- 3.2 The cost of the additional uplift is £0.153m.

4. Agenda for Change

4.1 The updated NCHC settlement for 2021/22 requires all providers employing registered nurses and delivering publicly funded care to pay nursing staff the increased pay settlement of 4% from 12 April 2021.
