1. Purpose

1.1. The purpose of this report is to inform and seek approval of the appointment of Depute Chief Officers and note membership changes to the Integration Joint Board (IJB).

2. Background

- 2.1. The Glasgow City HSCP Executive Team restructure was approved by the IJB on <u>25th June 2025</u> and the associated recruitment process for Depute Chief Officer posts was ratified by IJB Finance, Audit and Scrutiny Committee on 10th September 2025.
- 2.2. The IJB's Schemes of Delegation to Officers and Committees, at 1.6, states that The IJB will delegate to the Finance, Audit and Scrutiny Committee, the responsibility for convening an Appointments Panel to organise and oversee the recruitment to the posts of Chief Officer, Chief Officer Finance and Resources, Chief Officer Strategy and Operations and any other executive level posts that may in future be established. This panel must include the Chair and Vice Chair of the IJB. Recommendations for appointment will be provided by the Panel to the full IJB for appointments to be made.
- 2.3. Previously stakeholder representatives have been nominated from within existing IJB / HSCP engagement networks, however a new approach to recruitment of service user and carer representatives was proposed to and approved by the IJB on 14th May 2025.

3. Appointment of Depute Chief Officers

- 3.1. Following a rigorous recruitment process Kelda Gaffney, the current Interim Assistant Chief Officer for Adult Services and Chief Social Work Officer, has been appointed to the new role of Depute Chief Officer, Operations and Governance and Chief Social Work Officer.
- 3.2. Stephen Fitzpatrick, the current Assistant Chief Officer for Older People's Services and Primary Care and South Operations, has been appointed to the new role of Depute Chief Officer, Strategy, Innovation and Best Value.
- 3.3. Both officers will join the IJB as professional advisors and Kelda Gaffney will remain in the role of the Chief Social Work Officer.

4. Membership Changes

4.1. David Reilly, Stakeholder Representative for the Independent Sector is due to end his current term on 1st November 2025, but in discussion with the Independent Sector network and following a letter (Appendix 1) from Scottish Care on 21st August 2025 it has been confirmed that David will serve a consecutive second term on the IJB with Gillian Currie as his substitute.

4.2 Gary Dover, Assistant Chief Officer (ACO), has moved to a new post and will no longer perform the role of professional advisor to the IJB. This also leaves a vacancy for lead ACO on the IJB Public Engagement Committee which Gary also fulfilled.

5. Update on Stakeholder Recruitment

- 5.1. Previously stakeholder representatives have been nominated from within existing IJB / HSCP engagement networks, however a new approach was proposed and approved by the IJB on 14th May 2025.
- 5.2. The new approach acknowledges the level of commitment required by offering a more flexible arrangement for service user and carer representatives. The aim is to recruit 4 service user reps and 2 carer reps thus creating a 'pool' of 6 people with a maximum of 3 attending formal GCIJB meetings as per current arrangements. The aim of recruiting of additional members is to support these representatives to balance their role on the Glasgow City IJB and their personal commitments.
- 5.3. Following approval of this approach, officers advertised the positions and shared this with a range of internal and external networks to ensure the reach was as wide as possible. HSCP social media channels were also used to advertise the positions and application process.
- 5.4. Applications closed on 18th July 2025 and officers received around 20 applications for the available positions. Following a short-listing process, eight applicants have been invited to meet with the Chief Officer and IJB Chair (with support from officers) in September 2025, following which appointments will be confirmed and presented for approval of the IJB.

6. Recommendations

- 6.1. The Integration Joint Board is asked to:
 - a) Approve the appointments of the Depute Chief Officers set out in section 3;
 - b) Note the membership changes detailed in section 4; and
 - Note the update on the process for Carer and Service User Stakeholder Recruitment in section 5.
