# Glasgow SDCF – Progress Update

- Building works in progress and working at pace
- People with lived experience supporting the design, furnishings and décor to ensure environment is trauma informed
- Recruitment ongoing, aim for all posts to be filled by July 24
- Aiming for late Summer 24 opening
- Currently developing drug checking service with Scottish Government
- Community, business and citywide engagement ongoing

# Themes

- **Policing/Legal**

- Exclusion zone queries
- Will require an increase in police presence
- Police will need to remain at a distance

- **Impact on Area**

- Increase in drug use/drug dealing
- No drug issues in the area
- High drug use in the area
- Unhappy that facility is being situated in Calton/East End
- Understand reasons for location - hopeful that the service will address public injecting and associated needle litter

# Themes

- **Service Model**

- Encouraged by aftercare area and involvement of wider services
- Families and people with lived/living experience supportive of model
- Addresses stigma
- Additional supports required for homeless people
- Specific consideration required to encourage women to use the service
- Concerns that people who do not inject drugs cannot access the facility
- People will not have access to a safer environment after 9pm
- People may not use the aftercare area

## WE DID

You are concerned about increased drug dealing and violence in the local area when the service opens

We are working closely with Police Scotland to establish a community forum where concerns can be raised and resolved as quickly as possible once the service is operational

You are worried about increased anti-social behaviour in the local area

We are working with the evaluation team to ensure that any changes in anti-social behaviour will be measured and reported

The local community needs somewhere to raise concerns and get a response

We will create a local engagement forum that will continue throughout implementation and delivery of the pilot

## WE DID

Local residents need to know about the engagement sessions and get a chance to discuss their concerns with service leads

We scheduled engagement sessions at a variety of timeslots across community venues and promoted the sessions on posters, social media and sent out 18,000 flyers to local postcodes

A safer community would be a key measure of success

We have ensured this is included in the evaluation

It would be helpful if we could contact the service if we see someone injecting drugs in the vicinity/premises

We are realigning the ADRS city centre outreach team to the facility, and working with partners to develop an outreach response

## WE DID

Some service users of the SDCF may be homeless, will there be facilities to support them

We have added a shower room and clothing store to the service

People with lived experience should be involved in recruitment of staff

All posts being recruited have/will include people with lived experience. Leadership posts include a LE panel and 3<sup>rd</sup> sector rep on panel. Other posts will include a LE rep on the panel

Many people will want to go for a smoke after injecting, it's important they can do that and still come back in to receive aftercare services

We added a secure smoking area for service users to access from and return to the aftercare area

### Glasgow City's Safer Drug Consumption Facility

Glasgow City Health and Social Care Partnership is planning to establish a Safer Drug Consumption Facility (SDCF) in Glasgow City Centre.

#### Frequently Asked Questions

##### What is a Safer Drug Consumption Facility (SDCF)?

Safer drug consumption facilities (SDCFs) are supervised and controlled healthcare settings where people can consume drugs, obtained elsewhere, in the presence of trained health professionals, in clean and hygienic environments reducing the risk of overdose and infectious diseases whilst offering support and access to healthcare services.

They offer a compassionate, person-centred service which focuses on reducing the harms associated with injecting drug use and helps people access appropriate services to meet their needs. By doing so, they are able to reach an extremely vulnerable group who often do not engage with our existing services.

Safer Drug Consumption Facilities are also known as Supervised Drug Consumption Rooms / Facilities (SDCR or SDCF), Safe / Supervised Injection Facilities (SIF), Safer Consumption Rooms (SCR), Overdose Prevention Sites (OPS), Drug Consumption Rooms (DCR) and Medically Supervised Injecting Rooms (MISR).

##### Why are these services being proposed for Glasgow?

Following an outbreak of HIV in people who inject drugs in public places, a health needs assessment 'Taking Away the Chaos' was undertaken in Glasgow city centre. This found there are approximately 400 to 500 people injecting drugs in public places in Glasgow city centre on a regular basis. Injecting in public spaces increases the risk of infection and other drug related harms, and also causes a risk to the public from discarded injecting equipment and needles.

The report made a number of recommendations, including the introduction of a SDCF which a large body of high-quality research suggests will help reduce the health and social consequences of public injecting in the city centre. These potential benefits are described in more detail below (See 'What are the expected benefits of these services?')

Glasgow city centre is the focus of the proposal since local evidence tells us that this area has a high concentration of people who inject drugs in public places, especially in the south-eastern area. Locating the facility in the area where public injecting is already taking place will maximise uptake by the target population.

### Safer Drug Consumption Facility

Glasgow City Health and Social Care Partnership (HSCP) is working with NHS Greater Glasgow and Clyde (NHSGGC) and other partners to develop a pilot Safer Drug Consumption Facility (SDCF). This will be the first Safer Drug Consumption Facility in Scotland and the United Kingdom.

SDCFs are supervised healthcare settings where people can inject drugs, obtained elsewhere in the presence of trained health professionals in clean, hygienic environments. The service aims to reduce the negative impact that injecting outdoors has on local residents, communities and businesses, reduce the harms associated with injecting drugs on individuals and support people to access help to improve their lives.

The SDCF is due to open in 2024 and will be the first of its kind in the UK.
