Scottish Recommended Allowances for Kinship and Fostering Services

Purpose of Report:

To advise the IJB of the Scottish Recommended Allowances for kinship and fostering services agreed by COSLA and the Scottish Government and to seek agreement to implement the payment of the proposed allowances backdated to 1st April 2023.

Background/Engagement:

There have been discussions nationally for several years to agree a consistent Scottish Recommended Allowance (SRA) for kinship and fostering services. This was discussed previously in June 2023 in the [Foster Care Update](#) report. Foster Carers and Kinship Carers have been involved in a variety of discussions in relations to supports available to them and have been kept updated in terms to the proposed SRA.

This development is aligned to the recommendations contained within the Independent Care Review and delivery of the Promise.

| Fairer Scotland Compliance: | The Children's Transformation Programme actively seeks to reduce inequalities and to support children, young people, and carers to improve their quality of life and reduce the impact of health and social inequalities. Sustainable and stable placements for children and young people not only promotes the opportunity for better outcomes but significantly reduces the cost of additional placements and costs. |
| Financial: | The adoption of the Scottish recommended allowance has financial implications, these are detailed in the report. Additional funding of £2.365m has been received from the Scottish Government for this purpose and is intended to cover the difference between current rates paid by Glasgow and the SRA. |

1. Purpose

- 1.1. To advise the IJB of the Scottish Recommended Allowances (SRA) for kinship care and foster care services agreed by COSLA and the Scottish Government and to seek agreement to implement the payment of the proposed allowances backdated to 1st April 2023.

2. Background

- 2.1. In [March 2022](#) the IJB agreed to increase the kinship and foster care allowances for the 40% of children in Glasgow's foster and kinship placements where they were believed, at that time, to be below the anticipated SRA.
- 2.2. This increased allowances for kinship and foster carers with children 0-4 years from £137.18 to £146 per week and 5-10 years from £156.30 per week to £170 per week.
- 2.3. It was agreed the remaining 60% who were thought to be around or in line with the proposed national allowance would be sustained at that level until the outcome of the national review was known. That is, allowances for 11-15 years would remain at £194.54 and for those 16+ would remain at £236.60.

- 2.4. In Glasgow, an additional 4 weeks of allowances are made over the course of the year to cover birthdays, winter festivals and holidays. It is proposed that this will continue to ensure that no families are in detriment if the SRA is adopted.
- 2.5. Mileage is also paid to foster carers for anything out with their local area. It is proposed that this remains in place.
- 2.6. In [November 2022](#) the IJB also agreed to increase the fee to foster carers from £150 to £165.
- 2.7. Following discussions between the Scottish Government and COSLA over several years it has now been agreed that the Scottish Government will provide an additional £16 million of revenue to introduce a new SRA for foster and kinship carers across Scotland to be backdated to 1 April 2023. This was agreed by COSLA Leaders on 25 August 2023, following the recommendation of the Settlement and Distribution Group (SDG) on 16 August. The Scottish recommended rates are based on independent analysis carried out by Fraser of Allander Institute in 2018 on the cost of supporting a child.
- 2.8. The SRA is a key commitment in the Programme for Government and the Scottish Government's Promise Implementation Plan, published in March 2022. It aligns with the Scottish Government and COSLA's commitment to #KeepThePromise, and a shared priority of tackling child poverty and supporting the most vulnerable in society, especially given the ongoing cost of living crisis. Specifically, the SRA is intended to help ensure that children in foster and kinship care get the support they need to thrive and ensure there is parity in the financial support provided to kinship and foster carers, regardless of where they live in Scotland.
- 2.9. The SRA provides a recommended allowance that all local authorities are expected to pay as a minimum. Where local authorities are already paying above the SRA, it is expected that this will continue so that kinship or foster carers currently in receipt of the allowance will not be worse off because of this commitment.
- 2.10. The allowances are intended to cover the following –
- Food, toiletries, clothes, wear and tear
 - Hobbies and activities
 - Bedding, furniture
 - Pocket money/ toys
 - Insurance and utility bill increases
 - Daily access to a computer and the internet for homework/course work/ mobile phone
 - Transport costs for the child (for the purpose of attending review meetings, children's hearings, contact, travel to school, college or other educational facility)
 - Holiday costs to cover school holiday activities and family trips
 - Birthday/ Christmas or other cultural or religious events.

3. Financial Implications

- 3.1 The following table outlines the difference between current Glasgow allowances and the SRA.

| | 0-4 | 5-10 | 5-15 | 16+ |

- 3.2 Glasgow currently has 474 children and young people in our provided foster placements and 1,335 in kinship care placements.
- 3.3 The Glasgow City allocation is £2.365m, sufficient to cover the uplift in rates from 2021-22. It should be noted however, that the Glasgow City IJB previously chose to implement an increase to rates in 2021-22 at a cost to the IJB of £0.500m. Due to the early adoption of this increase, this additional funding will positively contribute, but it will not compensate for this increase, nor the previous investment made by the city over several years. Nevertheless, this development represents a positive step forward both nationally, but critically for Carers and for the children and young people they care for. This additional funding will supplement the established allowances in Glasgow and the additional funding will enable the HSCP to enhance the current allowances and strengthen the arrangements for both fostering and kinship.
- 3.4 The recent Fostering inspection also provided an updated and helpful insight into the challenges and this new proposal will align to the Service's desire to strengthen improvements around the actions outlined in the Foster Care Action Plan (Appendix 1).
- 3.5 The Champions' Board for Care Experienced Children and Young People will also provide a helpful platform to not only maintain the engagement of Foster and Kinship Carers around the ongoing monitoring and implications of the new SRA, but provide an opportunity for dialogue with carers around the financial arrangements and sustainability around the costs involved in raising children and young people now and in the future. The reconstituted Champions' Board is in the process of arranging its first meeting before the end of the year and this will take place on 6th December 2023.

4. Recommendations

- 4.1. The Integration Joint Board is asked to:
- a) Note the proposed Scottish Recommended Allowances;
 - b) Approve the proposed Scottish Recommended Allowances for kinship and foster carers and implementation of the new rates by Glasgow City Council, backdated to 1st April 2023
 - c) Instruct the council to uplift the rates paid to kinship and foster carers as outlined within this report.
