Representation of Younger People's Voices for the Public Engagement Committee

Purpose of Report:

The purpose of this report is to feed back to the Public Engagement Committee (PEC) work on how to consider younger people's voices being represented at PEC. This includes work that Business Development were tasked with to map how younger people are being engaged with across the HSCP, wider council family and stakeholders with the purpose of how the committee can be informed by this work.

Background/Engagement:

At a <u>PEC meeting in August 2022</u> a paper was presented with options to improve representation for younger voices at committee level and was followed up at a <u>PEC meeting in November</u> where members expressed interest in how we ensure that we can represent and engage the voices of younger people at PEC. Officers were tasked with taking forward engagement with key stakeholders to map existing engagement channels and report back and develop a network and robust communication channel to improve sustainability.

'The Promise' highlights the importance of Voice as one of its 5 foundations. It states, 'Active listening and engagement must be fundamental to the way Scotland makes decisions and supports children and families. There is no simple formula or standardised approach that will suit all.'

1. Purpose

1.1 The purpose of this report is to feed back to the Public Engagement Committee (PEC) work on how to consider younger people's voices being represented at PEC. This includes work that Business Development were tasked with to map how younger people are being engaged with across the HSCP, wider council family and stakeholders with the purpose of how the committee can be informed by this work.

2. Background

- 2.1 At a <u>PEC meeting in August 2022</u> a paper was presented with options to improve representation for younger voices at committee level and was followed up at a <u>PEC meeting in November</u> where members expressed interest in how we ensure that we can represent and engage the voices of younger people at PEC. Officers were tasked with taking forward engagement with key stakeholders to map existing engagement channels and report back and develop a network and robust communication channels to improve sustainability.
- 2.2. 'The Promise' highlights the importance of Voice as one of its five foundations. It states, 'Active listening and engagement must be fundamental to the way Scotland makes decisions and supports children and families. There is no simple formula or standardised approach that will suit all.'

3. Activity

- 3.1 Officers conducted a focus group in April 2023 with expert representation from children's services, carer's services, children's rights team and the Promise Participation Workers. This process was to seek advice and guidance from those who are experts at engagement with younger people on how we should proceed. At this meeting it was confirmed that the option for a position on the committee for a younger person to represent views wasn't a workable solution. Meetings occur during the day when younger people are at school/further education or work, it's an intimidating and bureaucratic process for a younger person to be engaged with and one person can't accurately represent all views, particularly that of lived experience. They also advised that the best way to proceed was to meet with key people over the following months to complete a mapping exercise to demonstrate routes of engagement and offer solutions to work closer with PEC to ensure oversight and representation.
- 3.2 Business Development officers then went on to attend a further fifteen meetings with representatives from:
 - o Children's Rights Services
 - o Glasgow Life
 - Education
 - Youth Health Service
 - Young Carers
 - Children and Families
 - Health Improvement
 - Wise Women

The purpose of these meetings was to help map activity and fora to begin to build a picture of engagement opportunities across the HSCP and key partners.

- 3.3 Appendix 1 shows the mapping activity and supporting materials. This initial phase has focused more closely on the HSCP and partner organisations, whilst further mapping with more Third and Independent sector stakeholders could be advantageous, there is representation on IJB and PEC to enable this engagement and officers throughout the stakeholders we met with demonstrated that they have good routes of engagement and partnership working with third and independent sectors working in a range of areas with younger people. Glasgow Life had also completed some mapping regarding *Youth Voice Activity in Glasgow*. Several organisations responded to inform this piece of work and detail Glasgow Life's network of influence and engagement.
- 3.4 From these meetings and supporting materials, officers were able to inform our mapping exercise and get a good sense of how to build robust links with these networks to enable more visibility for members of PEC from within the HSCP and its close partners.
- 3.5 We now have a range of contacts that will form a younger people network that will allow us to follow up on known pieces of work that reflect the priorities of younger people in the city and speculatively look for updates on new pieces of work to inform the forward planner for PEC agenda items. The network would assist the HSCP by supporting the following process:

Chart 1 - How PEC will be informed by network

Business Development officers keep a log of contacts and key pieces of work and place into forward planner

BD Officers contact for updates on known pieces of work to ensure timelines are realistic

BD Officers email round network well in advance of PEC agenda setting for any new pieces of work and schedule these in

BD Officers meet periodically with network members to remain infromed of progress of known work and discuss planned upcoming work

BD Officer attend forums and consultation groups where apropriate to advise on PEC

BD Officers perform a supporting role to prepare officers, partners and younger people to attend and participate in PEC

BD Officers added to newsletters and distribution lists for organisations

Organisations have been added to our engagmement logs

HSCP engagement will be shared with organisations to promote with their networks

BD Officers review newsletters and email updates for potential PEC agenda items and liaise appropriately

BD Officers review other for agenda to inform PEC and invite agenda items appropriately

BD Officers meet requiarly with Heads of Planning to update engagement log and discuss upcoming work and potential PEC agenda items.

- 3.6 All representatives that we met with work closely with their stakeholders to include younger people in the development and prioritization of services. The strategic direction, projects and work are completed in partnership with their service users demonstrating true co design and engagement as well as consultation and communication. This follows the principles of engagement set out in our participation and engagement strategy especially;
 - Working with others to improve health **Empowerment**
 - Designing and delivering services around the needs of individuals carers and communities **Responsive**
- 3.7 At present a range of items are already planned for the coming year and will be placed in the forward planner now that 2024/25 dates are confirmed. This plan is not exhaustive but meant to illustrate some of the potential future items and as pieces of work progress they may be updated or items superseded. It will also be informed by what younger people are telling us they want to feature via our networks.

- 3.7 Within the IJB and PEC there are carer, third and independent sector representatives to enable wider engagement with their own networks such as the carers reference group, providers forum and third sector fora including one specifically aimed at younger people working on The Promise work.

4 Summary of findings

- 4.1 Overwhelmingly we were told that meaningful engagement with younger people happens with good relationships, in environments that are comfortable and familiar to the younger people with some form of incentive like food and/or vouchers. Younger people need to feel that they are involved and thrive when they receive feedback or can see their efforts come to fruition. Strategic engagement feels repetitive and they can often struggle to see direct links between strategies, policies and their contributions.
- 4.2 In a <u>previous PEC report</u> the model of a younger person joining PEC on a regular basis as a contributor has been unanimously ruled out as a solution to ensure engagement. It was agreed at this stage that officers engage with partners who have expertise in the area to gain views from younger people on how they would want to engage with the committee and an action was noted on the rolling action log to identify a network of organisations and groups that represent younger people.
- 4.3 The proposed processes will allow a range of networks and areas of work to inform the PEC forward planner ensuring that youth voices and priorities are represented well within the committee in a meaningful way. Further mapping with additional stakeholders either by officers within the governance team or within the network of people involved with youth services will broaden the scope of the items and the range of people attending and contributing to PEC agendas in the future.

5 Other Fora

- 5.1 Currently Glasgow City Council has a Champions Board. This was established in 2007 with the remit of political and senior leadership to ensure that the needs of our care experienced children and young people are at the forefront of council policies and priorities. The board paused meetings during the Covid 19 pandemic and haven't resumed meetings.
- 5.2 Glasgow's Young Champions' Board (previously known as PAC People Achieving Change) was a group of care experienced children and young people who met regularly to provide mutual support and to give feedback to corporate parents about issues that affect them both positively and negatively. This group, too, became difficult to run during the pandemic and its sustainability was a challenge due to the changing needs of the young people and the availability of consistent support. The HSCP has recruited 4 Promise Participation Workers (PPW's) whose primary role is to be trusted advisors for all matters in relation to the Promise and to support the development of a Young Champions' Board or Champs' Board, as they prefer to call it.
- 5.3 The PPWs drafted a proposal regarding the Champs Board and how it will interact with the Champions Board, it was requested that approval was sought to resume these meetings. This proposal was approved by Glasgow City Council's City Administrations Committee in August 2023.

- 5.4 The reinstating of the Champions Board and the refreshing of the Champs Board could give the IJB and PEC a unique opportunity to ensure that care experienced younger people's voices are heard and represented appropriately in a forum that meets their needs and ways of working. More information regarding this opportunity and how PEC may link with it will follow when more information is known of plans moving forward.
- 5.5 Scottish Youth Parliament is currently in the election stage with forthcoming elections planned for November 2023.
- 5.6 Glasgow Youth Council members took the decision in April of 2023 that the council should be devolved, and a working group created to develop a new structure that would better represent the younger people of Glasgow. This is in the early stages with initial meetings happening over the Summer of 2023.
- 5.7 YC Connect (Young Carers) has previously been discussed at PEC as a division of the carers centre particularly for young carers to ensure that they feel involved and participate in a range of events. It advocates that young carers have a voice providing opportunities for a broad representation of younger carers needs and opinions in engagement and consultation activity. A successful summer programme of events and training opportunities has been run over the last two summers.

6 Recommendations
