Modernisation of Day Services for Adults with a Learning Disability

Purpose of Report:	To inform the IJB Public Engagement Committee of engagement activities being undertaken in connection with a programme of work underway to review how best we can improve and modernise day services for adults with a learning disability.

Background/Engagement:	<p>Glasgow City HSCP’s building-based services closed during the COVID 19 pandemic in line with guidance to minimise the risk of infection to vulnerable people. Other measures were put in place during that time to keep in touch with service users and their families, including increasing community-based activities where it was possible to do so. With day centre attendances having now returned close to pre-pandemic levels, it is considered the right time to take stock of our current provision, explore opportunities for improvement and to consider the longer-term service model against projected demand and need.</p> <p>The scope of the review is very much on exploring opportunities for service improvement, informed by learning, best practice and shaped by the input of people who access the services, their families and carers, and staff. This paper reports on initial engagement activity undertaken around this programme of work.</p>

1. Purpose

- 1.1. To inform the IJB Public Engagement Committee of engagement activities being undertaken in connection with a programme of work underway to review how best we can improve and modernise day services for adults with a learning disability.

2. Background

- 2.1. GCHSCP's building-based services closed during the COVID 19 pandemic in line with guidance to minimise the risk of infection to vulnerable people. Other measures were put in place during that time to keep in touch with service users and their families, including increasing community-based activities where it was possible to do so. With day centre attendances having now returned close to pre-pandemic levels, it is considered the right time to take stock of our current provision, explore opportunities for improvement and to consider the longer-term service model against projected demand and need.
- 2.2. The scope of the review is very much on exploring opportunities for service improvement, informed by learning, best practice and shaped by the input of people who access the services, their families and carers, and staff. This paper reports on initial engagement activity undertaken around this programme of work. The engagement activity will provide opportunities to improve the current service and to influence the development of the new build programme.

- 2.3. On average, the day centres at Riddrie and Carlton currently provide support to approximately 70+ individuals. The profile of need is between complex care and profound and multiple learning disability (PMLD). People accessing the service can therefore have high communication needs, require personal care, medication support and benefit from a variety of therapeutic supports.
- 2.4. Parents and carers from GCHSCP Learning Disability Day Care Services were invited to an in-person engagement event within Sense Scotland accommodation in September 2023. Follow-up in-person engagement sessions were arranged in both day care services in November 2023. To facilitate further feedback, an online and paper survey was circulated in January 2024. In total 36 people (37% of all families/carers) attended and contributed at the in-person sessions and 17 people participated in the survey.
- 2.5. At the engagement sessions, GCHSCP staff provided a brief overview of the purpose of the modernisation programme, including the ambition, should funding become available, to see new build accommodation replacing existing day centres. Staff adopted the [What Matters to You](#) approach to create a range of questions that would gather people's views, insights, and experiences with accessing and using the centres and their vision of future models of care.
- 2.6. A graphic illustrator was also in attendance at the Sense Scotland event to capture the meaning behind the spoken words and build up storyboards. The storyboards helped on the day to illustrate the findings from the event and the emerging key themes. Sample storyboards from that day are attached for information (Appendix 1).
- 2.7. The discussion at the event was challenging at times, for both the presenters and participants. This was due to the complexity and sensitivity surrounding the possibility of any change to existing services in the context of historical changes to Glasgow City learning disability day care service model that resulted in the closure of many day centres. It was clear that many families and carers were apprehensive about the possibility of any changes to the model or location of existing services.
- 2.8. Parents and carers spoke of the importance of familiarity for people using the centres and the challenges of managing change and transitions. Those challenges made some less keen on the potential for new build accommodation, preferring to look at options to upgrade existing buildings. Others saw advantages in new build accommodation, but requested a commitment that those accessing the service would not be moved to interim accommodation during any construction period.
- 2.9. Other feedback included comments that the opportunity should be explored for greater input in day centres from other healthcare specialists and to ensure staff are equipped with the training and knowledge around electronic communications aids and specialist dietary requirements.

- 2.10. On the whole, staff communication within the centres was applauded, as was the commitment and dedication of staff and the quality of care provided. Some communication issues regarding transport were highlighted for improvement.

3. Next Steps

- 3.1 Families and carers expressed a preference to be kept informed of progress through regular newsletters and through meetings at the day centres with staff. Action is being taken to do so, including the potential for meetings to be held online where this may better suit some families and carers. Our communication and engagement plan is attached for information (Appendix 2). The modernisation group will oversee communication and engagement activities to ensure they are inclusive and in line with the principles of GCHSCP's Participation and Engagement Strategy.
- 3.2 In addition to keeping families and carers well-informed, we are also keen to find the best way of involving them in shaping the work of the modernisation group. We are currently exploring a number of options to do so and will be in further dialogue with families and carers to seek their views. This will include seeking their involvement in the development of an EQIA.
- 3.3 Much of the initial engagement has sought views on the prospect of new build accommodation. This preparatory scoping work will continue in readiness should capital funding become available at a future point. However, moving forward, we expect the focus of engagement to be more on exploring the short-to-medium term areas for improvement. The modernisation group will ensure that stakeholders have the opportunity to influence the development of improvement work and that there is appropriate consultation and engagement, should any recommendations for service change emerge.
