**Community Link Worker Programme 2024/25: additional Scottish Government funding**

**Purpose of Report:**

The purpose of this report is to update the IJB on the offer of additional Scottish Government funding for the Community Links Worker Programme from 2024/25; and to note the approval by the Chief Officer and Chief Officer Finance and Resources, under delegated authority, on the ground of urgency.

**Background/Engagement:**

Since the completion of the procurement process for the new Community Links Worker (CLW) contract from 2024/25, the Scottish Government has confirmed in its letter dated 14 November 2023 that it will provide an additional £1.2m in funding for the CLW programme in Glasgow for 3 years. The funding will commence from 1 April 2024 and will supplement Glasgow City HSCP's Primary Care Improvement Funding that is aligned to the programme. This additional funding will enable the new contract to operate at the same level as 2023/24, meaning that none of the practices will see a reduction in their allocation of CLW resource.

The Scottish Government's offer is on a recurring basis for three years, but subject to annual Parliamentary approval of the Scottish Government Budget. This will be provided in addition to the HSCP's Primary Care Improvement Fund (PCIF) allocation. The funding is being offered to sustain CLW capacity at 2023/24 levels, and comes with the following conditions:

**1. Purpose**

- 1.1. The purpose of this report is to update the IJB on the offer of additional Scottish Government funding for the Community Links Worker Programme from 2024/25; and to note the approval by the Chief Officer and Chief Officer Finance and Resources, under delegated authority, on the ground of urgency.
- 1.2. As IJB approval could not be obtained within the required timescale, and in view of the urgent requirement to accept the Scottish Government's offer of additional funding, these proposals were approved by the Chief Officer of Glasgow City IJB and Chief Officer, Finance and Resources under the delegated authority set out in the [IJB Scheme of Delegation](#) to officers.

1.3. Officer approval was in consultation with the IJB Chair and Vice Chair.

## 2. Background

- 2.1. 80 GP practices (57% of all practices) in Glasgow City have community link workers (CLW). Last year 12,797 new referrals were made to CLWs, 43,847 appointments and a total of 15,657 individuals supported.
- 2.2. Earlier this year the IJB awarded £2.186m for 2024/25 from the core Primary Care Improvement Fund (PCIF) for the new CLW contract, to allow it to commence on 1 April 2024 and to avoid any gap in provision should there be a change in suppliers as consequence of the procurement process. At the point of issuing the tender, the HSCP had not received any commitment from the Scottish Government that it would continue with the current level of additional funding (£1.35m).
- 2.3. The PCIF award of £2.186m represented a 38% reduction from the available funding in 2023/24 (£3.256m). The new contract would reduce CLW capacity to 0.5 whole time equivalent per practice – a significant reduction for many practices, however, this would still result in all 80 practices continuing to receive CLW support for their patients, albeit from some it would mean a reduction from a full time worker. The service specification was designed with the scope to expand, should further funding become available.
- 2.4. The procurement process completed earlier this year, and the Health & Social Care Alliance secured the 7 lots to deliver practice based CLWs in the city. Work has commenced by the two current suppliers to manage any potential TUPE obligations.
- 2.5. Since the completion of the procurement process, the Scottish Government has confirmed in its letter dated 14 November 2023 that it will provide annual funding of £1.2m for the CLW programme in Glasgow for 3 years. The additional funding will commence on 1 April 2024 and will supplement Glasgow City HSCP's Primary Care Improvement Funding. This additional funding will enable the new contract to operate at the same level as 2023/24, meaning that none of the practices will see a reduction in their allocation of CLW resource.
- 2.6. The Scottish Government's offer is on a recurring basis for three years, but subject to annual parliamentary approval of the Scottish Government's budget. This will be provided in addition to the HSCP's Primary Care Improvement Fund (PCIF) allocation. The funding is being offered to sustain CLW capacity at 2023/24 levels, and comes with the following conditions:

- 2.7. Condition c) was stipulated on the basis that the HSCP will in the three-year period, commencing in 2024/25, continue to receive a PCIF allocation, which is in line with its current allocation (subject to annual resource allocation formula – NRAC, adjustments).
- 2.8. In line with paragraph 4.2.4 (section f) of the [Scheme of Delegation from the IJB to Committees and Officers May 2019 0.pdf \(hscp.scot\)](#), Glasgow City HSCP's Chief Officer recommended to the Chair and Vice Chair of the IJB that we should accept the offer and they agreed with this recommendation. The Chief Officer, therefore, wrote to the Scottish Government on 14 November 2023 to accept the offer of funding.
- 2.9. The Scottish Government offer of funding and the Chief Officer's letter of acceptance are attached at Appendix 1 and Appendix 2. The report to the Chief Officer and Chief Officer, Finance and Resources seeking approval under delegated authority is attached at Appendix 3.

### 3. Recommendations

**COMMUNITY LINK WORKERS FUNDING FROM 2024/25**

1. Thank you for your letter of 27<sup>th</sup> October 2023 in which you advised us that Glasgow City Health and Social Care Partnership is unable to accept the Scottish Government's offer for £600,000 on a recurrent basis, subject to that amount being matched by the HSCP.
2. Given the high value that Ministers place on Community Link Workers (CLW) and recognition of the levels of need in Glasgow City, I am writing to confirm an annual allocation of up to £1.2 million commencing 2024/25. This is on a recurring basis for three years, subject, as always, to annual Parliamentary approval of the Scottish Government Budget. This will be provided in addition to the HSCP's Primary Care Improvement Fund (PCIF) allocation.
3. The funding is being offered to sustain CLW capacity at 2023/24 levels and with the following conditions:
  - a) It is provided to fund Community Link Workers in the city's most disadvantaged communities and will be used entirely for this purpose.
  - b) It cannot be used to offset other pressures or be redeployed.
  - c) In accepting this offer, the HSCP undertakes to continue, over the three years from 2024/25, to commit a portion of future PCIF allocations which is in line with the HSCP's current PCIF investment in CLWs.
4. Condition c) is stipulated on the basis that the HSCP will in the three-year period, commencing in 2024/25, continue to receive a PCIF allocation which is in line with its current allocation (subject to annual NRAC adjustments).

5. This offer to secure CLW capacity in Glasgow City is within the context of an extremely difficult fiscal position and underlines the importance Ministers place on the CLW service.

6. I appreciate that this has been a very unsettling time and that the procurement process was complex. I am very grateful for the constructive collaboration we have had with the HSCP throughout. I hope this is helpful and would be very happy to discuss further. I look forward to our continued joint working on Primary Care.

- 2.4. The procurement process completed earlier this year, and the Health & Social Care Alliance secured the 7 lots to deliver practice based CLWs in the city. Work has commenced by the two current suppliers to manage any potential TUPE obligations.
- 2.5. Since the completion of the procurement process, the Scottish Government has confirmed in its letter dated 14 November 2023 that it will provide annual funding of £1.2m for the CLW programme in Glasgow for 3 years. The additional funding will commence on 1 April 2024 and will supplement Glasgow City HSCP's Primary Care Improvement Funding. This additional funding will enable the new contract to operate at the same level as 2023/24, meaning that none of the practices will see a reduction in their allocation of CLW resource.
- 2.6. The Scottish Government's offer is on a recurring basis for three years, but subject to annual parliamentary approval of the Scottish Government's budget. This will be provided in addition to the HSCP's Primary Care Improvement Fund (PCIF) allocation. The funding is being offered to sustain CLW capacity at 2023/24 levels, and comes with the following conditions:

- a) It is provided to fund Community Link Workers in the city's most disadvantaged communities and will be used entirely for this purpose.
  - b) It cannot be used to offset other pressures or be redeployed.
  - c) In accepting this offer, the HSCP undertakes to continue, over the three years from 2024/25, to commit a portion of future PCIF allocations which is in line with the HSCP's current PCIF investment in CLWs.
- 2.7. Condition c) was stipulated on the basis that the HSCP will in the three-year period, commencing in 2024/25, continue to receive a PCIF allocation, which is in line with its current allocation (subject to annual NRAC adjustments).
- 2.8. In line with paragraph 4.2.4 (section f) of the [Scheme of Delegation from the IJB to Committees and Officers May 2019 0.pdf \(hscp.scot\)](#), Glasgow City HSCP's Chief Officer can recommend to the chair and vice chair of the IJB acceptance of the offer and write to the Scottish Government to accept the offer of funding.
- 2.9. The Scottish Government offer of funding is attached. If approved a report will be provided to the IJB in January to update on the approval under delegated authority and will include the correspondence accepting the funding and this report seeking approval under delegated authority.

### 3. Recommendations

- 3.1 The Chief Officer and Chief Officer, Finance & Resources (acting on behalf of the Integration Joint Board) are asked to:
- a) Accept the Scottish Government's offer of additional funding for the CLW programme as outlined in section 2 of this report.
