Background/Engagement:

GP practice partnership of Dr June Campbell and Ms Christine Bell submitted a formal application on 8th October 2024 to NHS Greater Glasgow and Clyde to withdraw GP services from their branch surgery premises within Cardonald Medical Centre, 1831 Paisley Road West, Glasgow G52 3SS. They propose to deliver services from their main premises at Ashton House, 3 Ashton Road, Glasgow G12 8SP and their other branch surgery at Springburn Health Centre, 200 Springburn Way, Glasgow G21 1TR.

The guidance issued to Health Boards in relation to branch surgery closures advises that decisions are taken only after full consultation with local communities and other interested parties; and that any decisions taken align to other strategies designed to improve patient access to services. A consultation on the application to close the branch surgery commenced with patients and wider stakeholders on Thursday 20th March 2025 and concluded on 12th June 2025.

The guidance states that all responses, results from meetings and the patient survey must be considered by the HSCP's Senior Management Group who will decide on the application and inform the IJB of its recommendation. In line with the IJB's delegated authority arrangements for officers, Glasgow City HSCP's Chief Officer and Depute Chief Officer, Finance and Resources agreed (in consultation with the Chair and Vice Chair of the IJB) that the application could be approved on the grounds of urgency, as this would allow the Health Board and the practice to expedite the next stage of the closure process. |

1.1. The purpose of this report is to update the IJB on the application by Ashton Medical Practice to close their Cardonald branch surgery; and to note the approval of the application by the Chief Officer and Depute Chief Officer, Finance and Resources, under delegated authority, on the ground of urgency.

2. Background

2.1. The Ashton practice made an application to the Health Board last October to close its branch surgery in Cardonald Medical Centre. After the completion of the stakeholder consultation and an Equality Impact Assessment, officers of Glasgow City HSCP's Primary Care Management Group agreed on 25 June 2025 to recommend the closure of the branch to the IJB and Health Board. This recommendation was made on the basis that closing the branch surgery would help to promote the sustainability of the overall practice at its other 2 locations. Officers have made a commitment that those patients who do not want to remain registered with the Ashton Practice, will be supported to register with other local practices in their area.

- 2.2. Officers estimated that the timescale for closing the branch, including the time to seek alternative local practices for those patients who do not want to remain with Ashton, would take approximately 6 months after approval by the IJB. If the decision to accept the request to close its branch surgery in Cardonald Medical Centre was delayed until the next IJB meeting, officers had concerns that the sustainability of the overall Ashton Practice would be compromised.
- 2.3. As IJB approval could not be obtained within the required timescale and in view of the urgent requirement to allow the Health Board and the practice to expedite the next stage of the closure process, the application was approved by the Chief Officer and Depute Chief Officer, Finance and Resources under the delegated authority set out in the IJB Scheme of Delegation to officers. Officer approval was in consultation with the IJB Chair and Vice Chair.

3. Recommendations

- 3.1 The Integration Joint Board is asked to:
 - a) Note approval of the application from the Aston Medical Practice to close its branch surgery in Cardonal Medical Centre by the Chief Officer and Depute Chief Officer, Finance and Resources under delegated authority, on the ground of urgency; and
 - b) Note the approval was undertaken in consultation with the IJB Chair and Vice Chair

1.1. The purpose of this report is to update the Chief Officer (on behalf of the Integration Joint Board) on a proposal to accept the application by Ashton Medical Practice to close their Cardonald branch surgery; and to request approval under delegated authority, on the ground of urgency.

4. Glasgow City Council and NHS Greater Glasgow & Clyde

1.2. As IJB approval could not be obtained within the required timescale, and in view of the urgent requirement to approve the closure of the branch, the Chief Officer of Glasgow City IJB is asked to approve under the delegated authority set out in the IJB Scheme of Delegation to officers.

2. Background

2.1 The GP practice partnership of Dr June Campbell and Ms Christine Bell submitted a formal application on 8th October 2024 to NHS Greater Glasgow and Clyde to withdraw GP services from their branch surgery premises within Cardonald Medical Centre, 1831 Paisley Road West, Glasgow, G52 3SS. They propose to deliver services from their main premises at Ashton House 3 Ashton Road, Glasgow G12 8SP and their other branch surgery at Springburn Health Centre, 200 Springburn Way, Glasgow G21 1TR.

- 2.2 Glasgow HSCP has followed the guidance that has been provided by the Health Board's Primary Care Support Team. This guidance advises that decisions are taken only after full consultation with local communities and other interested parties; and that any decisions taken align to other strategies designed to improve patient access to services. A consultation on the application to close the branch surgery commenced with patients and wider stakeholders on Thursday 20th March 2025 and concluded on 12th June 2025.
- 2.3 The guidance includes a governance flow chart for authorizing (or not) requests by practices to withdraw services, such as branch closures. The guidance states that all responses, results from meetings and the patient survey must be considered by the HSCP's Senior Management Group who will decide on the application and inform the IJB of recommendation. The IJB is then asked to ratify (or not) the officers' decision.
- 2.4 Glasgow City HSCP's Primary Care Management Group agreed to the application on 25 June 2025. Their decision was based on the detailed report and Equality Impact Assessment.
- 2.5 Given the next IJB meeting will not take place until September 2025, it is requested that the Chief Officer and Chief Officer, Finance and Resources approve the application under delegated authority as this will allow the Health Board and the practice to expedite the next stage of the closure process.
- 2.6 A report to the IJB meeting in September 2025 will ask members to note the decision by the Chief Officer and Chief Officer, Finance and Resources to approve the closure of the branch surgery under delegated powers.
- 2.7 If the request is approved, NHSGG&C will amend the contract with Ashton Medical Practice to allow the practice to close its Cardonald Branch; to complete the administrative processes that are required to facilitate the closure and to ensure that patients can either remain with the Ashton practice or are able to register with another practice.

3. Recommendations

- 3.1 The Chief Officer and Chief Officer, Finance and Resources (acting on behalf of the Integration Joint Board) are asked to:
 - a) Approve the application from Ashton Medical Practice to close their Cardonald Branch Surgery.
