## Remit:

The Audit and Finance Committee is responsible for monitoring the financial performance of the Glasgow Health and Social Care Partnership; reviewing audit and inspection reports; and for promoting the observance high standards of financial propriety.

Specific remit to include:-

> Monitoring internal financial control, ensuring that appropriate financial controls are in place

Ensuring that performance is monitored against budget and that the budget plan is clearly linked to the strategic plan

- > Endorsement of capital schemes promoted by the parent bodies
- Approval of the annual audit plan

Initiating and undertaking specific audits and/or reviews of any matters falling within the remit of the committee or requested by the Integration Joint Board

Receiving and considering summaries of internal and external audit reports which relate to any issue falling within the remit of the Integration Joint Board

- > Promoting value for money studies and best value
- > Taking an overview of the Integration Joint Board's Service Reform programme
- Review of Risk Registers

Referring back to the Integration Joint Board for its consideration any Service/Financial performance issue which might have implications for policy development coming within the remit of the Integration Joint Board

Approval of the Annual Accounts and Annual Governance Statement prior to presentation to the Integration Joint Board

## ROLE DESCRIPTION INTEGRATION JOINT BOARD SUB-COMMITTEE and COMMITTEE CHAIRS

This role profile applies to Chairs of the Integration Joint Board's Executive Subcommittee; Finance and Audit Committee; and Public Engagement Committee.

- To provide leadership, including initiating policy, where appropriate;
- To chair any Committee, working group etc. in accordance with its terms of reference, fostering and maintaining a disciplined approach by Committee/working group members, maintaining highest standards of conduct and ethics;
- To decide the action to be taken in implementing those matters of policy and performance, relating to the Committee's remit, including where appropriate, monitoring and review;
- To take responsibility, and to be held accountable for, any decisions taken;
- To facilitate the full range of opinions of committee members and the public (as appropriate) at committee and other meetings and ensure that their contributions are controlled in accordance with Standing Orders;
- To respond to or deal with any issues arising from Integration Joint Board meetings;
- To act as a spokesperson within and outside the Glasgow City Health and Social Care Partnership in relation to the Committee's remit;
- To consult interested parties as part of the development and review of policy and the scrutiny of performance, where appropriate;
- To act as an advocate for the Integration Joint Board and Health and Social Care Partnership both internally and externally;
- To develop effective relationships with partner organisations and regional and national bodies as appropriate;
- To communicate the decisions and actions of the Integration Joint Board and its committee as appropriate.
