3.	LDAN consultation
	Session plan was produced to focus the meeting on gathering feedback from LEF members on the Learning Disability, Autism, and Neurodivergence Bill, and the Scottish Government Consultation and ENABLE Scotland's Rights Now campaign, which aims to influence the Bill.  20240301 LI Andy Miller, Strategic Lead: Participation & Partnership, Scottish Commission for People with Learning Disabilities presented the background to the bill and spoke of the Scottish Commission for Learning Disability Report The State of Our Rights which aims to influence the LDAN Bill, and the proposed Human Rights Bill.
