	The Chair, Robert Smith welcomed everyone to the meeting. Apologies were given and recorded.
<b>2.</b>	<b>Previous Meeting Notes and Matters Arising (RS)</b>
	Previous minutes were approved.
<b>3.</b>	<b>NHS GGC Mental Health in-patient engagement</b>
	<p>Lisa Martin presented the responses to the Mental Health Services Survey carried out during March and April 2024. The survey focused on people's awareness and experience of Mental Health Services and support in NHS Greater Glasgow and Clyde.</p> <div data-bbox="323 522 388 585"></div> <p>MHS Phase One Engagement Survey S</p> <p>Lisa highlighted the feedback focused on the importance in community-based services and the delays in receiving mental health support especially through GP practices and Community Mental Health Teams. Respondents also expressed the need to improve staff training in relation to mental health support and improve integration of services across primary, secondary and community care.</p> <p>Lisa shared that NHSGGC will be undertaking further engagement on how we plan and deliver Mental Health Services for the future and invited members of the LEF to be part of this engagement.</p> <p>Members were able to provide peoples experience of delays within Mental Health Services and the lack of support following discharge from Mental Health Services.</p>
<b>4.</b>	<b>NHS GGC Moving Forward Together Lisa Martin, PEPI Manager</b>
	<p>Lisa informed the group that the team are reviewing their Moving Forward Together agenda and meeting structures and as part of that there will be opportunities for public representatives to be involved.</p> <p>She also identified that public partners are needed to support the unannounced and announced hospital inspections and requested that if anyone was interested in getting involved to advise herself or Katrina. Involvement will require people to be available at short notice and attend online meetings.</p>
