The NW Locality accommodation priorities are:

William Street Refurbishment is due to open in the Spring 2022 and aims to promote agile working and an improved work space for HQ staff and administration. The ground floor level is being extended and will accommodate the Sexual Assault Referral Centre – main hub for West of Scotland revised services. The new Sexual Assault Service, for the first time, will be located in a dedicated purpose unit with a separate entrance and open 24 hours a day - 7 days a week centre

Church Street Refurbishment – the HSCP working in partnership with Greater Glasgow and Clyde Health Board to secure funding to completely refurbish and extend this building. The intention is to incorporate Gullane Street services, Primary Care and GP Services (as there are a number of single handed GP practices in this area) and looking at potential of incorporating Centre for Community Health (Partick) services. This would then free up space in order to accommodate Sandyford Central – Sexual Health Services which are in the old Eye Infirmary - another very old building.

The project is designed and costed – progressing to the planning application and permission stage. Funding still to be secured.

Drumchapel Shopping Centre has recently been identified as a priority area for Glasgow City Council and the HSCP will work in partnership to move this project forward. A new building would incorporate all HSCP buildings and services presently in the Drumchapel area. This is a long term ambition/target and dependant on securing funding.

Janet explained the changes in Primary Care with extended multi-disciplinary teams and the new GP contract that enabled GP's to operate as expert medical generalists requires improved accommodation and facilities. In order to accommodate multi-disciplinary teams and increase capacity and service provision in the community - work is being planned in two phases

Phase 1 - Woodside Health and Care Centre – create 4 new Treatment Rooms and a Meeting Room in the vacant Pharmacy space.

Phase 2 - Drumchapel Health Centre— looking to make changes in design to increase Treatment Room space and similarly in **Centre for Community Health, Partick**, create additional Treatment Rooms.

Janet concluded the presentation by advising that there two main groups looking at accommodation - the HSCP Locality Accommodation – Restart Group and a GGC wide Accommodation Strategy Group. The GGC Health Board are going to be reviewing all their buildings in NW of Glasgow next year. Janet would keep LEF members up to date with any engagement opportunities in relation to this review.

Q. Lillian asked what services would be located in Knightswood – the transport links are poor in this area which has a high population of older people. There is a need for Health Centre in the area.

A. Janet advised that the GGC wide Accommodation Strategy Group was wide ranging and would look at buildings, services, location of teams and gaps in services. Areas where there are fewer services should be highlighted during this review.

4. Glasgow City HSCP Strategic Plan Engagement (Janet Hayes/May Simpson)

The new HSCP Strategic Plan has been put back one year because of Covid and this give us the opportunity to consult more widely. In order to consult widely - 9 short term planning groups have been set up to plan engagement. The planning groups are – Older people, Children's services, Mental Health, Learning Disability, Housing and Homelessness, Drug and Alcohol services, Carers, Public Protection and a Strategic Group (3rd sector, Locality planning, Commissioning, volunteering and Equalities)

The timeline to produce the new HSCP Strategic Plan is:

Dec – March 2022	plan engagement
March – Sept 2022	consult with public, key partners, hard to reach groups, staff etc
Sept/Oct 2022	Draft Plan written
Oct 22 – Feb 23	Consultation on draft Plan
March 2023	Plan presented to IJB
April 2023	HSCP Strategic Plan published

Covid has changed the way be deliver services - like the increased use of new technology – this needs to be reflected in the new plan. Also the Strategic Plan may change from a 3 year plan to a 5 – 10 year plan – they IJB is still considering the length of the plan

5. HSCP Integrated Joint Board (IJB) - Health and Social Care Nominations (May Simpson)

The HSCP Integrated Joint Board has a number of non-voting representative – two Health and Social Care Representatives, one Carers representative, an Independent Sector representative and a 3rd Sector representative. The 3 year term of these representatives ends in March 2023 and we are seeking either re-nomination of existing representative Ann Souter and Ann Scott (Health and Social Care) or new nominations for these positions. The process and timeline is

Two Health and Social Care Representatives – letter sent out, information distributed, information webpage set up and posted on HSCP on 6/12/21- closing date 4/2/22

Nomination form is very simple – contact details and statement of interest and experience. May will send out information and papers to all members next week. There are pre agenda meetings and the papers are now sent out timeously.

There are two informal substitute positions which Robert Smith and Alan McDonald hold. Robert had advised he is standing down from the substitute position as he is now unable to make the IJB meetings due to work commitment as they are all held on a Wednesday. It was noted from discussion that while it was important for these position to be filled it can be a daunting task for many service users due to the amount policy/committee papers to fully understand and digest. Sadie Gordon observed some of the meetings can be very formal and found them not always welcoming – making it difficult to participate and wondered what could be done to make them friendlier.

The point was made that to give a community perspective all groups of service users should have the opportunity to be involved as different groups had their own experience of using services.

6. NW LEF Planning 2022

May proposed that the first quarter of next year would be similar to last year – LEF and wider public questionnaire focusing on service priorities and engagement re Strategic Plan in the month of February followed by (hopefully) blended LEF engagement sessions informed by the results of the questionnaire. Once restrictions have ease further and more groups are meeting work towards a re-launch of the LEF's. All agreed with this proposals. –
