Robert Smith welcomed everyone to the NW Locality Engagement Forum meeting with sad news that our member Roy Greaterox had sadly passed last week. He will be greatly missed by his family and community.

Robert advised member that Jane McGuire had resigned from the LEF he thanks her for her volunteering and involvement. Apologies noted.

<b>1</b>	<p><b>Minutes of NW LEF – 27 June 2019 – agreed.</b>  <b>Matters Arising – RS added to service areas and issues – Child Poverty.</b></p>
<b>2</b>	<p><b>Review of Sexual Health Services (Jennifer Schofield, Fiona Noble and Runima Kakati)</b>                  Jennifer showed a video and circulated the Summary Leaflet detailing the background to the review, feedback gathered, Sexual Health Service Implementation Plan and the recommendations. The following questions and discussion points were noted  <b>Q</b> Why are you moving services from Drumchapel – an area of high need?  <b>A.</b> Through research it was found that that attendance at the Drumchapel service was low – some people from G15 choose to access the Clydebank or Sandyford service instead of their local service.   <b>Q.</b> Why is there no services in Possilpark and do young people still have to go to Royal for the morning after pill?  <b>A.</b> If the recommendations are accepted there will be a 5 day a week</p>

service in Woodside Health and Care Centre which will serve the Possilpark/Maryhill/Milton etc areas. Young people will be able to access Emergency contraception at local Pharmacies – they no longer have to go to the Royal.

**Q.** Concern was raised about the proposals – it will mean poorer access for young people from the Drumchapel to Faifley area.

**A.** We are working with the Youth Health Service to look for a solution. We hope to deliver a service for young people in the Yoker/Drumchapel area that is open between 4.30 – 6.30pm. We will also be testing the on line service for people with ‘straightforward’ (repeat prescription of oral contraception etc) sexual health needs in the Drumchapel area.

**Q.** Concerns regarding the raise of HIV in Glasgow?

**A.** Injecting drugs and risk taking behaviour is not specifically included in this review but is linked. This is a priority for Sexual Health Services who work in partnership with Addiction service and Homeless services to tackle the rise in HIV. The review recommended wider access to STI testing and work is being done with local Pharmacies to improve access to kits and sexual health services.

**Q.** How accessible is your online service for people with disabilities, visual impairments, English not a first language etc?

**A.** Point noted – Jennifer and colleague meeting with the IT Company next week to discuss developing the online service – will raise these points at meeting.

**Q.** How much is the review linked to financial pressures and reducing budgets?

**A.** There is always budget considerations but the review pressure was from unmet need and recruitment/retention of staff. It is very difficult to recruit Speciality Doctors. We are training Advanced Nurse Practitioner to deliver more services, working with Consultants and GP’s to develop better ways of delivering services and working with Pharmacist colleague to deliver more services in the community.

**Q.** Is there an Educational role for Sandyford?

**A.** This is not mentioned in the review as it is seen as a core function of the service. There is a Young Person team who work directly with vulnerable young people and we work closely with Health Improvement colleagues who deliver service to young people in the community and in schools/with Education services.

**Comment** – a number of members happy with the proposal for a Saturday
