**Item (4) Delivering the Arts Strategy for the new Parkhead Health Hub
Jackie Shearer Project Planning Officer.**

Jackie Shearer gave a visual presentation on the arts strategy programme which included an overview of the key commission for Parkhead Hub's entrance area. She added that Bespoke Atelier were the design agency appointed through a rigorous selection process to both the entrance and children's area.

For the entrance area, an illuminated large-scale panel will depict the local area through different design motifs. Using laser technology, shapes and patterns will be cut into the panel.

The children and young people's area, a wallpaper has been created with fun icons, recognisable characters and familiar landmarks. Community workshops are taking pace to enable all age groups to create some of the imagery to provide a broad appeal to those visiting the Hub.

The group were pleased to see the work-in-progress to date and liked the way it developed the history and heritage of the area's textile industry into the design process. Jackie also updated on a range of general creative engagement programme.
