



PPE Distribution Hub: Social Care Providers, Unpaid Carers & Personal Assistants

## Background

The Scottish Government, with the support of NHS National Service Scotland (NSS) has established Social Care Hubs within each Health & Social Care Partnership (HSCP) across Scotland, for the allocation of Personal Protection Equipment (PPE) stock to Social Care Providers. This covers care homes; care at home providers; unpaid carers; personal assistants; sheltered housing services; supported housing; housing support; children's homes and hospices.

# **Process to Request Supplies**

### **Providers**

If you have a Care Inspectorate Registration Number please contact:

You will be asked for your Care Inspectorate Registration Number and your 6 digit PPE Provider ID.

One allocation of stock is allowed per week. Upon receipt of your provider ID, our system will advise if you have received supplies within the last 7 days.

If allocation approved, you will be asked to provide your Organisation's name, address, and provide a contact name of who is placing the order.

You will then be asked to provide number of items of PPE that you require.

You will be advised if this is within the allocation available to you and if so if you would prefer to collect or receive a delivery of the items.

You will then be allocated a collection or delivery slot.
