## 1. Background

Glasgow City Council (GCC) recognises the concerns raised regarding the local environment and the impact of antisocial behaviour in the area. In particular, issues surrounding discarded injecting equipment have been a longstanding challenge. We want to assure you that we remain fully committed to delivering meaningful and lasting improvements, working together to create a safer, cleaner, and more supportive community for all.

We are actively working alongside key stakeholders—including community representatives, the Health and Social Care Partnership (HSCP), Police Scotland, Glasgow Alcohol and Drug Partnership, Thistle Management Team and Community Forum, Network Rail, Morrison's, and local businesses to directly address the unique needs of the Calton community.

Local and City leadership, including Elected Members, have been engaging with residents, carefully listening to their concerns, and collaborating with departments such as GCC Neighbourhoods, Regeneration, and Sustainability (NRS) to ensure that issues are met with meaningful action.

#### Addressing Drug-Related Litter and Safety

Concerns about discarded needles have been ongoing for many years and were a significant factor in the opening of *The Thistle*, which aims to reduce drug-related litter. To support this initiative, we carried out thorough deep-cleaning efforts both prior to and following its launch, ensuring a safer environment for all residents. However, we recognise the continued concerns and have further increased our presence on the ground to actively address them.

Recent initiatives by GCC Neighbourhoods, Regeneration, and Sustainability (NRS) have focused on extensive deep-cleaning efforts across the Calton Ward, particularly in areas where drug-related litter has been identified. Our teams conduct regular monitoring to remove needles and other hazardous materials, reinforcing our commitment to maintaining a cleaner and safer environment for residents.

Discarded needles can be reported for removal via the online form, by calling 0141 287 9700, or through the My Glasgow App.

Additionally, HSCP has coordinated outreach services to support individuals injecting away from home, providing guidance and assistance to help them access further support.

To further reduce drug-related litter, we have installed large-capacity sharps bins in key areas, including Elcho Street and the Morrisons Gallowgate car park. These bins have been successful in addressing similar issues elsewhere in the city, and we hope to see positive results in Calton as well.

This Action Plan intends to demonstrate each aspect of the work being carried out in the area, not just at present, but in the years leading up to this plan.

## 2. Previous Targeted Activity

Date	Concern	Response
2021 to present day	Concerns were expressed for safety at the Hunter & Havannah St open space.	Following combined efforts to clear up and improve the open spaces, ASB reports have declined.  This long term project, on private land, has involved regular monitoring of the area, and collaborative working with partners including Network Rail, student accommodation blocks on Hunter St, Police Scotland and developers.  Following a series of consultations and community meetings, the final stage of development is due to start 25/26 and all stakeholders continue to monitor the area and work together on improvements.  In 2025 the Avenues project has seen new lighting and pavements in the area as part of ongoing plans.
2021 to present day	Discarded injecting equipment at Elcho St	There has been regular monitoring of this area, with GCC Streetscene, and removing discarded injecting equipment weekly. Once the sharps bin pilot in the city centre was complete, Elcho St was highlighted as location to also receive a large capacity sharps bin once funding was identified.

		In May 2025 Deep Cleans were completed at Elcho St and the Sharps Bins installed. Injection equipment on street greatly reduced and bins are being used.
2022 to present day	ASB and drug related litter at Little Dovehill.	GCC Streetscene carried out large scale clean up at the upper car park at Little Dovehill and removed a large amount of discarded injecting equipment and related litter. GCC Parks cut back bushes and trees.  Injecting away from home at this site has largely decreased although the area continues to be monitored both by HSCP Outreach teams and GCC.
		Further development of residential housing to commence here 25/26.
October 2024	Clear up of large open drug injection site at Barrowlands Park and installation of temporary Herras fencing	Area is open and safer for public use. GCC are currently engaging with stakeholders to find a long term solution.
January 2025	GCC carried out a deep clean in areas around Hunter St in lead up to Thistle opening	The Thistle is now open and operating.
April 25	Discarded injecting equipment within public car park.	GCC NLT are working with partners such as Morrisons to monitor and uplift injecting equipment and other litter in the area.  Resources are being examined to provide additional street sweeping in the wider area.
April 25	Concerns about drug paraphernalia close to paths at Green St.	GCC Streetscene attended open space between Claythorn Park and Green St at London Road to remove mixed drug paraphernalia and to clean up paths at location.  Area is checked daily by GCC Streetscene.  Development is underway to refurbish the school here.

		GCC NRS will make improvements to the open space including better pavement surfaces and to cut back trees to improve lighting.
May 2025	Discarded drug related litter within the public realm.	In collaboration with Network Rail, Deep Cleans completed at Elcho St and Morrisons Car Parks. Sharps Bins installed at both locations. Injection equipment on street greatly reduced and bins are being used. Area is checked daily by GCC Streetscene.
		Tureen St school is to refurbished to provide social housing at Elcho St in 2026.
May 2025	Environmental safety at Tobago St, including fly tipping, injecting equipment and overgrown shrubbery.	Multiple departments from GCC cleared up the fly tipping, rubbish was removed, bushes were cut back.
		Area is checked daily by GCC Streetscene.  A long term solution to develop this area of land is being explored.
June 2025	Residents do not feel informed of efforts being made in the area, or of upcoming plans.	A reassurance letter has been sent to Calton residents. This will also signpost how to engage with community councils, elected members, and find help and advice. NRS NLT continue to attend the Thistle Community Forum and update on residents via Calton Community Council.
