1. Purpose of Report

1.1 To note the content of the final version Full Business Cases for the new Gorbals and Woodside Health and Care Centres, along with the associated project bundling paper. In doing so, to ensure members are sighted on key issues and are satisfied to approve the Full Business Cases (FBCs).

2. Approval Process and Timescales

*Note: This IJB paper has been issued in advance of the meeting of the Glasgow City Council Executive Committee. Notification of the Committee's decision to approve the Full Business Cases, or otherwise, will be confirmed to IJB members at their meeting on 15th March 2017.

- 2.2 The Hub Project Steering Group was appraised of the status of the FBCs and associated key issues at a specially convened meeting on 7th December 2016. The Project Boards for the Gorbals and Woodside developments have also been sighted on the content of the Full Business Cases.
- 2.3 Glasgow City Council has previously approved a capital contribution towards the cost of both Woodside and Gorbals projects. The implications of ESA10 now require that this be replaced by a unitary charge, with Scottish Futures Trust undertaking that, under the principle of 'no better, no worse', the Council will not be financially disadvantaged as a result of this change. This matter will require the approval of the Council's Executive Committee on 2nd March 2017.
- 2.4 In early January 2017 the funders for the project, Aviva, withdrew their offer of funding because they had reached the limit of their prescribed fund. They have been replaced by Nord LB, who is offering funding on very similar terms. Updated key dates are now Financial Close at March/April 2017, advance works starting on site in February/March 2017, and completion now expected September/October 2018.

3. Design of GP Reception Areas

- 3.1 The FBCs reference the concern expressed by GPs to the planned 'open' design of GP reception areas and that sign-off on room data sheets by GPs currently remains outstanding. (All 8 GP practices at Woodside and 2 of the 4 GP practices at Gorbals have opposed an open GP reception design.) The primary concern expressed by GPs is the safety of their reception staff, as well as concerns over confidentiality. Glasgow City HSCP Executive Team has considered the issue of reception areas and remains of the view that the new health and social care facilities should have open reception areas throughout to deliver a more welcoming environment for patients and service users and considers that health and safety or operational risks can be managed appropriately. This view was informed by the core design principles approved by NHSGGC's Capital Planning Group, which took into account national and local design guidance.
- 3.2 In the current absence of GP sign-off and for the purpose of both FBCs, the design of reception areas will proceed as currently planned (i.e. an open reception design) and Glasgow City HSCP will take responsibility for signing off GP room data sheets.
- 3.3 IJB members are asked to note the respective positions of the Glasgow City HSCP Executive Team and GPs on this issue and endorse a proposal for Glasgow City HSCP to undertake a learning exercise from the recently opened Maryhill Health and Care Centre. The learning exercise will review the use of open receptions at that facility, in the context of the concerns expressed by Woodside and Gorbals Health Centre GPs. In doing so, Glasgow City HSCP will also liaise with East Renfrewshire HSCP to share learning with regard to the newly opened Eastwood Health and Care Centre, which was chosen as the benchmark reference design for new primary care health centres.

3.4 Output from the learning exercise will guide whether there is a need for the Partnership to consider whether to alter the design of GP receptions for Gorbals and Woodside Health and Care Centres. It is proposed that the learning exercise be carried out between March and May 2017. Thereafter, the findings and recommendations from it will be brought back to the Glasgow City Integration Joint Board for final approval.

4. Recommendations
